A frivolous claim, often called a bad faith claim, refers to a lawsuit, motion or appeal that is intended to harass, delay or embarrass the opposition.

A claim is frivolous when the claim lacks any arguable basis either in law or in fact Neitze v. Williams, 490 U.S. 319, 325 (1989). That means, in a frivolous claim, either: "(1) 'the 'factual contentions are clearly baseless,' such as when allegations are the product of delusion or fantasy;" or (2) "the claim is 'based on an indisputably meritless legal theory.'" Livingston v. Adirondack Beverage Co., 141 F.3d 434, 437 (2d Cir. 1998).


If a court decides a claim is frivolous, the court can dismiss the case, order the party which files the frivolous claim and the party's attorney to pay any reasonable expenses, including attorney's fees incurred as a result of the frivolous claim. I purposely constructed my claim to mostly include FACTS (scientific and historic) since I noticed the pattern of ALL CLAIMS being denied as frivolous (Westlaw has well over 10,000+). Now that I have the definition above, the argument really is about embarrassment (why?).

- c) I HAVE CURRENTLY EXHAUSTED ALL KNOWN POSSIBLE AVENUES FOR RECOURSE
 - included in this response is:
 - (1) Civil Action Logs
 - (2) Law Enforcement Logs
 - (3) Federal Law Enforcement Logs
 - (4) Sworn Affidavit showing my implant (for targeting attacks and I believe I have several)
 - (5) Hacking Remediation Logs (reason for break-ins and required for ongoing CONTAINMENT)
- d) 28 United States Code Annotated §1361
§1361. Action to compel an officer of the United States to perform his duty (*investigate hacking*)

The district courts shall have original jurisdiction of any action in the nature of mandamus to compel an officer or employee of the United States or any agency thereof to perform a duty owed to the plaintiff

- e) At face value I am asking the defendants a single question:
What can a person do if they are constantly attacked with electronic warfare weapons?
I am NOT alleging that they are the ones responsible or involved in any way, I have purposely put John Doe Agency as the first defendant because I believe this is likely a private enterprise.

What happens in the instance if the defendants don't have an answer for this as well?

- 2) failure to have a licensed counsel representing it
- HUMAN FREE WILL can't afford a licensed counsel (why we get targeted). The ongoing pattern is a Targeted Individual almost always ends up going broke due to NO ONE HELPING. This is the business model of covert harassment and then people end up being desperate enough to do anything to make ends meet, an example is *committing crimes* or being dependent on someone.
 - I purposely constructed my claim as more of a symbolic gesture. This technology really exists and there really is a rendition market. The goal is NOT to accuse any specific entities but to have specific leaders and their representatives aware of the existence of this technology and with this knowledge they can hopefully NOT become victims and hopefully they can assist common folk.
 - HUMAN FREE WILL respectfully requests to keep this public facing name as the plaintiff and continue the discussion until forced to refile as under an executive's name or another victim's.
- 3) electronic warfare tactics (Document 1-1 Exhibit 2)
- ALL COMMUNICATIONS are continually faced with disruption issues (**HARD TO VERIFY INFORMATION**)
 - all Targets should NOT TRUST what they read online (Statement on Electronic Warfare)
 - mail continues to be tampered with and I still have **not received** this ORDER to Show Cause
 - cell phone service either does *not send or receive* calls and messages or gets rerouted (troll)
 - BUSINESS DONE IN PERSON since the above is a daily occurrence (hacking, jamming, spoofing)
 - the main goal is to ISOLATE to CONTROL your ENVIRONMENT (*mostly through hacking*)

II. DISCUSSION (EVERYONE BENEFITS)

The discussion is NOT about mind control, electronic harassment, and direct energy weapons; the discussion is about **accountability**. There is an entire Electronic Warfare community that the defendants are a part of. This suit poses a single question: *What can a person do if they are constantly attacked with electronic warfare weapons?* **ANYONE CAN BECOME A VICTIM!**

This is most likely an issue of FAILED CHECKS AND BALANCES. There is more to my story but this is becoming more and more an American story. There is an agenda to my constant targeting by people I most likely have no affiliations with (or want). They have access to this technology and won't stop until (a) they use me to fulfill an agenda or (b) I die so they can do this to someone else to fulfill that agenda. All I have been doing is enduring since there is NO WHERE to go for relief. (Document 1-1 Exhibit 1 will provide a list and summary of some well-known victims and their tragic outcomes)

III. CONCLUSION (DON'T DENY HUMAN FREE WILL)

The ONLY reason I have filed this Federal suit is because I have exhausted ALL known possible options for relief. My life, liberty, and pursuit of happiness are being denied with electronic warfare weapons and tactics. With EVERYTHING I present I find it outrageous that I have still not spoken in person with ANYONE with regards to what has occurred to me to date. There are over 10,000+ similar cases filed and ALL have been denied even to be heard in person. FACTS: I have non-consenting implants, I have lost a lot of time and money continuing to be attacked, I have knowledge as to technology and tactics (which continue to evolve: why not the response?). I truly just want to be LEFT ALONE IN MY OWN HOME. I have approached several different law enforcement agencies to look into my situation. There is NO GOOD way to contact anyone in this field in the FEDERAL GOVERNMENT. This is really my LAST RESORT and I plead with the court to NOT DENY HUMAN FREE WILL!

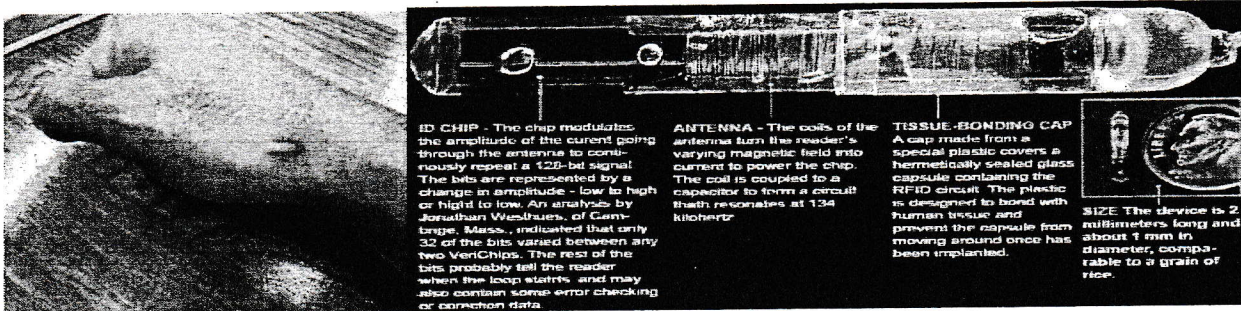
