STATEMENT ON SERVICE

On 12/2/2022 HUMAN FREE WILL filed a Statement on Electronic Warfare briefly describing what it is. Electronic Warfare involves Information Operations (Fake News) and Plausible Deniability (No Accountability) which allows criminals to get away with acts of crimes by colluding with each other. The main goal is to impede and deny victims (via hacking, jamming, rerouting) electrical signals. EVERYTHING that runs on electricity CAN BE HACKED (humans run on electrical signals).

Since filing the Statement on Electronic Warfare I continue to experience:

- Even more harassment via FULL SPECTRUM attacks
- Daily sleep deprivation via weapons placed near by
- 3 known break ins (now missing paperwork and important files on computer)
- Mail continues to go missing (ORDER to Show Cause and Opinion have not arrived)
- My print Wall Street Journal and Morning Call newspapers keep going missing
- Continue to experience intermittent use of my cell phone and internet service
- **STILL Having a hard time getting to Philadelphia for legal and servicing assistance**
 - Car has been tampered with and VERY LITTLE public transportation options

The main goal of this statement is to report what has been going on since my last filing. I probably missed a SERVICING DEADLINE but with Electronic Warfare weapons and tactics, I continue to experience verification issues with REAL information, REAL addresses, or to even CONFIRM really what to do as to proper procedures as a first time pro se filer. I now can't even go to the public library here in Allentown to look things up because this network is hacked as well. 4 YEARS OF THIS EVERY SINGLE DAY. Things seem to escalate when criminals continue to go unchecked and **no one does things in person!**

- 11/21/2022 dropped off legal packet to the Allentown US Attorney's Office
- 11/21/2022 mailed via CERTIFIED MAIL to the rest of the defendants
 - Funny business with the DNI and SECDEF zip codes in the delivery confirmations
- 11/28/2022 dropped off legal packet with the civil process clerk at the Philadelphia US Attorney's Office (learning that I might need a Certificate of Service so I might need to do everything ALL OVER AGAIN in front of the civil process clerk – *proper procedure?*)
