**STATEMENT ON ELECTRONIC WARFARE**

Electronic Warfare (EW) – any action involving the use of the electromagnetic spectrum or directed energy to control the spectrum, attack an enemy, or impede enemy assaults.

- The purpose is to deny (hacking, jamming, spoofing **COMMUNICATIONS** are techniques used)
- An element of Information Warfare (closely linked to Psychological Warfare)

Electromagnetic Spectrum (EM) – if you sense anything that means you are receiving spectrum signals

- The human brain is basically a receiver and interprets the full EM spectrum in various ways
- Visible light is only a small part of this naturally occurring spectrum (not visible - microwaves)

**WHO HAS THE ABILITY TO CONDUCT ELECTRONIC WARFARE?**

On 6/14/2022, the State of Pennsylvania had a civil action hearing: HUMAN FREE WILL v. RCN & SERVICE ELECTRIC. The goal was to get off a private network I was routing to on the first hop (only a Network Engineer or Technician can do this). As a senior level Cloud Engineer I wasn't considered an Expert Witness and my case was dismissed and nothing was done.

Being on an unknown private network I experience:

- Security cameras get turned off remotely
- EVERYTHING I DOWNLOAD CAN'T BE TRUSTED
- Denial of Service attacks that prevent me from doing anything online (like work)
- EVERY WEBSITE I VISIT CAN'T BE TRUSTED (provide a brief example with PACER)

On 11/3/2022 HUMAN FREE WILL filed this federal civil action to tie in the entire business model while continually getting ALL MY ELECTRONICS hacked and personally getting attacked with FULL SPECTRUM weapons positioned somewhere in my vicinity. The goal is to eventually assist other fellow Targeted Individuals and educate leaders on the latest in science and technology that probably is not even commercially available; but used on the general public until something gets done to stop them.

Electronic Warfare involves Information Operations (Fake News) and Plausible Deniability (No Accountability). Most Targeted Individuals will blame someone they know. Others will blame some part of the government: a popular and well deserved ones are the military, security, and intelligence agencies (Secret Services). Other countries do it on our home soil and they go unhindered with the help of the above. People don't realize that private companies do it as well (called a competitive advantage). Since filing this federal civil action I continue to experience:

- Even more harassment (gang stalking but kind of more friendly now – I wave hi)
- Daily sleep deprivation via direct energy and bio effects weapons near by
- 6 known break ins and the ONLY thing I can verify is my printer doesn't work
- Mail continues to go missing or comes days late (unable to sign up for alerts)
- My print Wall Street Journal tends to go missing when the market drops
- Had to take out a second loan to continue this fight (and pay bills and rent)
- Continue to experience intermittent use of my cell phone and internet
- **Having a hard time getting to Philadelphia for legal and servicing assistance**

The main goal of this statement is to report what has been going on since filing. With all my electronics somehow not working when I need it, I now find myself in the public library typing this up. I will continue this good fight and try to rush submitting what I have before it goes missing. 4 YEARS OF THIS EVERY SINGLE DAY. Usually people consider us Targeted Individuals as "crazy" (easier to discredit). If you did your own homework and realized there actually is an industry; people would lose respect for what some people actually do for a living (especially to children). The goal is to be left alone so I can move on with the remainder of my life. To accomplish this, I need to remove all of the non-consensual implants I have accumulated throughout the years working in a government capacity (very appreciated).
