Introduction

For over 50 years, secret research has been ongoing in this country into various methods for controlling the human mind and body. Electronic Harassment

- doing "skits" on the street which involves information only the target should know but has been found out via surveillance of the target
- stealing and vandalism of the target's possessions.”

Bio-electromagnetic Weapons

A weapon system that operates at the speed of light, that can kill, torture, enslave and escape detection. Harlan Girard

The Ultimate Weapon

Electromagnetic weapons operate at the speed of light; they can kill, torture and enslave; but the public are largely unaware that they exist, because these weapons operate by stealth and leave no physical evidence. Electromagnetic weapons have been tested on human beings since 1976. By widely dispersing the involuntary human test-subjects, and vehemently attacking their credibility, it has been possible for the United States to proceed with these human experiments unhindered by discussions or criticisms, let alone opposition.

This ultimate weapon system is currently being deployed in Iraq. The US Air Force and the Marine Corps refer to it as “active denial technology”, as if it were used purely for defense, but it is not..

Reading Brain Waves and Mind Control

In 1959, Saul B. Sells, a professor of social psychology at a minor US university submitted a proposal to the Central Intelligence Agency (CIA) to build for them the most sophisticated electroencephalography machine that would have an integral computational capacity to analyze and, hopefully, make sense of the brain waves it recorded. In other words, the professor proposed to make a machine that could tell the CIA what a person was thinking, whether or not the person wished to disclose that information.

The CIA approved the project in 1960, adding some library research with five objectives. The fifth objective of the research was, “Techniques for Activating the Human Organism by Remote Electronic Means”. The entire assignment was thereafter known as MKULTRA subproject 119, MKULTRA being the CIA’s notorious mind control programme. It was based on the erroneous notion that the Soviets already possessed the means to control minds and the US had to catch up as rapidly as possible.

The documents pertaining to MKULTRA subproject 119 are now held in the National Security Archives (a non-governmental organization) at George Washington University in Washington, D.C. [1]. John Marks, author of *The Search for the Manchurian Candidate: The CIA and Mind Control*, (Times Books, New York, 1979) donated the MKULTRA documents; his book was republished by W.W. Norton & Company, Inc., New York, 1991 and is still in print.

Project Bizarre followed MKULTRA subproject 119 in 1965. The purpose of Bizarre was to record and analyze the complex microwave signal allegedly being beamed at the American Embassy in Moscow by the Soviets from a building across the street. The interesting thing about Project Bizarre is that while the United States has denied to this very day that there could be

adverse health effects from microwave radiation, it immediately suspected that “the Moscow signal” was producing a variety of health effects in Embassy personnel, particularly in the successive ambassadors at whose office it was claimed the signal was being beamed. At the same time that the State Department was testing embassy personnel for DNA breaks produced by the Moscow signal, it felt constrained from complaining to the Soviets because the power of their signal was a tiny fraction of what the US said was a safe, human exposure level. Journalist Barton Reppert has written the most authoritative account of the Moscow signal [2]. (Editor’s note: DNA breaks from exposure to mobile phones have been confirmed in recent lab research

Converting Sound to Microwaves

In 1973, Joseph C. Sharp, an experimental psychologist at Walter Reed Army Institute of Research performed an experiment that was pivotal to the development of the torture equipment being shipped to Iraq today. He had James Lin set up equipment in his laboratory which converted the shape of sound waves into microwave radiation that enabled him to hear himself vocalize the names of the numbers from one to ten in his head, by-passing the mechanism of his own ears. This particular experiment was never published but is mentioned in Lin’s book, *Microwave Auditory Effects and Applications*, published in 1978 [5].

The experiment has been confirmed in US Patent 6 587 729, “Apparatus for Audibly Communicating Speech Using the Radio Frequency Hearing Effect” [6]. This patent is for an improved version of the apparatus used in the 1973 laboratory experiment, issued on July 1, 2003 and assigned to the Secretary of the Air Force. It provides scientific evidence that it is possible to hear threatening voices in one’s head without suffering from paranoid schizophrenia.

Why has this patent been published openly at a time when the US Government is practicing a degree of secrecy that rivals Stalin’s Kremlin? I have no satisfactory answer, except to say that the apparatus in the patent has already been superseded by equipment that achieves the same effect by far more sophisticated means. It blocks the normal processes of memory and thought by remote electronic means, while at the same time supplying false, distorted and/or unpleasant memories and suggestions by means of a process called “synthetic telepathy”. The equipment that produces synthetic telepathy is sometimes referred to as “influence technology”.

While voices and visions, daydreams and nightmares are the most astonishing manifestations of this weapon system, it is also capable of crippling the human subject by limiting his/her normal range of movement, causing acute pain the equivalent of major organ failure or even death, and interfering with normal functioning of any of the human senses. In other words, any of the tortures with which the words Guantanamo Bay have become synonymous can be achieved by remote, electronic means.

Instruments of Torture

Influence technology is also capable of persuading the subjects that their mind is being read, that their intellectual property is being plundered, and can even motivate suicide or the murder of family, friends, and co-workers. During the years of the so-called “War on Drugs” (which preceded the “War on Terrorism”), letters that the involuntary human subjects had written or

were about to receive regularly vanished from the mail, as though the government had a huge covert operation through post offices across the country. When George Herbert Walker Bush became president (in 1989), the incidence of co-worker killings in the post offices became so great that the expression “going postal” began to replace the commonly used expression of “going crazy”. The killing of co-workers in other workplaces began to command more media attention too [7].

I estimate that the cost of imprisoning a human being in his/her own body and applying unremitting torture is US\$5 000 000 to \$10 000 000 a year (see below).

By “unremitting torture” I mean exactly that. Because there is no visible evidence left by this new torture equipment such as damage to the skin, it is possible to torture the involuntary human subjects for 24 hours a day, 365 days a year. This can be done and is being done even on Christmas and Easter [8].

I arrived at my estimate on the cost of testing/using electromagnetic weapons on a human subject by visiting a cable TV channel that specializes in the sale of goods over the air 24 hours a day. I questioned the number of technical staff required, their working hours and salary range; also the number of back-up personnel required to prepare the programming for broadcast. I did not inquire about the cost of electronics and the schedule by which it is depreciated. I have estimated a cost for depreciation that is included in my estimate of the cost of torturing one involuntary human subject for one year.

Torture is a labor-intensive business. What objective would justify this investment? Could it be something as insane as to rule the world by enslaving the democratic governments of the more populous countries? This objective is certainly consistent with the United States’ disdain for, and hostility toward, the United Nations, the international conventions and covenants it has ratified in the past and customary international law [9].

On 1 March 2001, the Marine Corps announced a new non-lethal weapon, “active denial technology”. It produces enormous pain by allegedly boiling the molecules of water in the human skin without damaging the skin itself. As described in an article published in *New Scientist*, it employs pulsed electromagnetic radiation at a frequency of 95 GHz with a range of about 600 meters [10]. There have been several new reports in the magazine in 2005, including one published in July [11], describing volunteers taking part in tests to determine how safe the Active Denial System (ADS) weapon would be if used in real crowd-control. The ADS weapon’s beam was reported to cause pain within 2 to 3 seconds, and becomes “intolerable after less than 5 seconds”.

Active denial technology is the cornerstone of the system employed to torture 2 000 persons in the privacy of their own homes, not only in the United States but around the world, wherever countries have signed Status of Forces Agreements with the United States [12]. Allegations of torture were first received from countries with which the United States has a special intelligence-sharing relationship i.e. the United Kingdom, Canada, Australia and New Zealand. Then reports began to arrive from the conquered countries where the United States still has large numbers of troops stationed, i.e. Germany and Japan. When France rejoined the military arm of NATO in the late 90s, we began to receive allegations of torture in France. Very recently we have begun to receive allegations of torture from India, where American companies have begun

to outsource, not only help lines, but also programming [13].

And then there is the case of Russia, where the involuntary, human subjects of torture experiments appear to be both numerous and well organized. I have been told reliably that every Russian scientist who could speak English has now found a home in an American university or government laboratory. This is plausible, considering the frequently voiced American worry that Soviet era experts in nuclear weaponry and biological warfare might find employment in Iran. It is a fact that at the end of World War II the US Army swept through Germany in an operation called Project Paperclip, recruiting, in particular, Nazi rocket scientists and experts in aerospace medicine. Some other scientists were recruited simply to deprive the Soviet Union of this resource. So what has become of the Soviet scientists who didn't speak English? In time we will find out for certain, but for now it is a safe guess that at least some of them have been employed to study the Russian value system and decision making processes by torturing other Russians with American "influence technology" [14].

Two interesting and important articles on bioelectromagnetic weapons have recently appeared in the *New Scientist*: "Maximum pain is aim of new U.S. weapon" and "Police toy with 'less lethal' weapons", both written by David Hambling [15]. See also US. Patent 6 536 440 of March 25, 2003 [16].

Since completing this article in mid-June 2005, it has come to my attention that the Israelis are deploying a device called "The Scream", which sends out bursts of audible, but not loud sound at intervals of about 10 seconds. A photographer at the scene of a demonstration said that he continued to hear the sound ringing in his head even after he covered his ears. This suggests to me that the active agent is electromagnetic rather than acoustic. In other words, the Israelis have come up with a device that is far cleverer than our "active denial technology". It not only deters rioters, but also issues an audible warning that it has been turned on, which the US device does not, leaving it entirely to the enlisted men operating it to determine how much burning pain their adversaries receive. The margin for error with the US device is unconscionable. It may as well be called a lethal weapon because in practice it very frequently will be [17].

Gang Stalking

Three years ago a male caller phoned my private detective agency and asked to speak with me. The caller said he was the victim of “gang stalking” and described how it was being done. I was reluctant to believe such a thing and asked him where I could find additional information on gang stalking.

Initially, I thought the caller was delusional. It was the same thought I had had about previous callers who described being harassed by—for lack of a better description—several people in their neighborhood. For example, a woman from Baltimore had earlier

told me she was finding items in her home mysteriously moved around while she was out. Her outgoing mail would reappear in her mailbox, several days after she sent it. Another male caller said he was certain he was being stalked and that he was not crazy.

These, and other calls, began to make me doubt that these callers were imagining these events.

When interviewing prospective clients, one of my first steps is to try to sort out the “crazies” from the sane, which is difficult at best, especially over the phone in only a few minutes. With these calls, I would start by asking the

caller if he or she was taking any legal or recreational drugs/medication and whether she had ever been treated for dementia, hysteria, hallucinations, etc. I would also ask if there might be a person, persons or group that the caller may have injured or offended in some way—someone who would be motivated to do this. Was the caller a whistle blower? Our staff would also ask if the caller had a former friend or lover who might be having trouble letting go.

Prior to learning about gang stalking, I would tell callers to keep a journal with as much detail as possible. I

would also tell them to contact me once they had something tangible for our agency to build on, such as a vehicle tag number and/or descriptions of any of the individuals. This advice hasn't changed: I continue to recommend keeping a journal. The mere practice of keeping a journal can be therapeutic and help the writer to keep his or her facts straight.

Gang stalking (or "organized stalking") involves employing techniques of psychological warfare in a methodical and well-orchestrated manner. Often, victims become the target of ridicule by friends and family because the occurrences are so hard to believe. These tactics are intended to weaken the target to the point of physical and psychological collapse. Now that the number of targets has increased to the point where victims can network with one another, they find out that the same tactics are being used everywhere.

The reasons why someone is initially targeted for gang stalking may vary. Sometimes, the victim may be a political activist. Others may have simply been in the wrong place at the wrong time. Apparently, corporations have been known to hire these stalking groups to silence people who were once in their employ. Members of the stalking gangs may be lied to about the target; possibly convinced that the person is a deviant who should be driven out of town.

Many people ask: Why would anyone engage in this kind of activity? In order to answer this question, it is important to realize that the person who has decided to target an individual is not the same person (or persons in this case) doing the stalking. Gang stalking is stalking by proxy. Those who select the target may be doing so for any number of reasons, including revenge, jealousy, or a desire to keep someone silent. It may be that the perpetrator considers physically harming the victim to be too extreme or too

risky. In fact, this kind of psychological attack can be a far more effective way to harm someone. It ruins a person's life while leaving little or no evidence to incriminate the perpetrators.

The reasons why the stalkers engage in the activity may have little or nothing to do with why the person was targeted in the first place. It is not inconceivable that the participants don't know why the person has been targeted, or that the stalkers have no personal stake in harassing the victim. Certain things are clear: This is an addictive behavior as well as a form of entertainment for the stalkers. From descriptions of victims who have come face to face with their stalkers, the stalkers seem to derive a vicious pleasure from bullying their victim. Clearly, stalkers like the feeling of being "in control." For stalkers, organized stalking is probably the ultimate experience in "reality" entertainment. To the perpetrators, the targets are merely part of an ongoing game. But make no mistake: This is a vicious crime.

According to David Lawson, author of *Terrorist Stalking in America*, in some cases the victim may simply be a practice target, or used as an example to those in the stalking group of what can happen to them if they anger the group in some way. The intense fear of becoming a target serves to keep the members of these stalking groups tied to the group. It is a terrifying prospect because the gang members are intimately aware that the lives of the targets are being destroyed.

The types of activities that occur are often subtle; sometimes they can't be distinguished from normal everyday things that go wrong. But these activities typically occur much more frequently than they would normally. Lawson writes that the victim is intentionally "sensitized" to the presence of the stalkers, so that he or she will know that the occurrences are orchestrated. It is a psychological reign of terror intended to make victims look crazy and to keep

them in a constant state of hyper-vigilance (anxiety and stress) concerning what will happen next.

For example, perpetrators (who appear to frequently have access to their targets' homes) may sometimes come into the house while the target is out and move things around a little bit, spread some dirt on the floor or on furniture, or move an item from the house to the car. Usually, they will not cause enough damage to involve the police. In some cases, the victim does not know she or he is being targeted. It just appears as though the world is full of very rude people, and everything he or she owns constantly breaks.

Getting Help

In most instances of organized stalking—because there is little or no damage to property and victims are usually physically unharmed—local police will do little to help. If a victim does have tangible proof to present to the police—such as property damage or bodily harm—the next steps will be to identify the perpetrators. This can prove very difficult. How a private detective agency can help is by providing counter surveillance, or shadowing, to obtain tangible proof of the stalking to show to local authorities.

At the risk of encouraging "copycat" behaviors, I have written about gang stalking for two important reasons. The first reason is to make people aware of these occurrences, and to possibly remove any self-doubt they may experience if this happens to them personally. The second is to make people more sensitive to the concerns of a friend or family member who may be experiencing some or all aspects of gang stalking.

I, Amy swear to state true facts. I was placed into an unethical human experimentation program during my childhood. My mother, due to being very poverty stricken and lacking education, in the 1970's raised her four children on governmental assistance. At age 7, I had experienced some strange activities occurring on the inside of my body which caused me to feel these energies overly stimulating my sexual organs.

I was in kindergarten and I and another student began to engage in sexual stimulation with these energies stimulating our bodies. We both had sudden urges to urinate at the same time and to go inside the restroom and engage in sexually-stimulated activities.

Throughout my childhood and adulthood I had a serious problem with these energies coercing me to always have an urge to use my fingers and engage in masturbation. Some of the children who had experienced this type of unethical experimentation conducted on them had parents who appeared to be having mental breakdowns, were alcoholics, child molesters, drug dealers/addicts, pimps, prostitutes, and convicts, just tried to elevate in life or were receiving some type of government assistance because of their children. As a result, the life of one of my brothers went completely the opposite of their plans and was partially ruined from being experimented on with mind-altering technologies. Another's life was spent on drugs, alcohol and mostly prison although he has the intelligence for an electrician that's never been to school and a natural talent for repairing electronic devices.

The other brother was rerouted to the state of Washington and diagnosed for displaying bipolar behavioral traits. He could have easily been a businessman with knowledge of how to earn and invest money, while others in the family do not have that type of financial discipline to save their money.

My son was an unwitting experimentee with mind-altering technologies overriding his conscious mental state not to heed to me warning him about the streets and gang members. My son has never had a criminal background until I started discovering I and other family members were experimentees from the infamous CIA MK-ULTRA program's mind-altering technologies which have never ceased, nor desisted from operating in our lives.

Back in 1997, I had experienced temporary loss of the senses of touch, hearing, smell, taste, my vision got blurry, my body temperature had increased to a very high, unnatural and unfamiliar temperature that caused my entire body to work in complete opposition to itself.

I first started displaying flu-like symptoms that caused fluids to fill my lungs and cause me to always grasp for air and to have breathing complications. As a result, my natural breathing becomes shallow and I experience rattling, wheezing, congestion, and tightness in my chest cavity. I had to take a leave of absence from my place of employment.

I experienced energies causing me to have headaches to where I was not able to keep my head lifted up and I was afraid I was slowly coming out of my body, as these forces began to slowly drain my natural energies from me. My body had become incapacitated by these energies and my head felt like it was about to explode from the energy applying pressure to it. My body was incapacitated for two weeks and I became bedridden. I was only able to use the restroom, or lift my head up to see my family and tell them I feared I was dying from something attacking my system. I remembered speaking to my son's father from prison the last time before his life was stolen from him by these mind-altering experimenters.

For years they have been projecting their voices from long distances into my head with remote stimulations, stating that I had HIV/AIDS and that I was going to die until I discovered that I was one of many experimentees.

Since then and moving back to the city of Richmond, CA I lost both of my full-time jobs and was sexually assaulted by a former policeman.

My horrific experiences with technologies continued and were used to either degrade my natural mental state, dehumanize me or to stimulate and exploit my sexual organs and energies to not allow them to function properly.

Looking back, I believe the experimentation was conducted to cause me to recant my claims about the sexual assault of former police officer Patrick J. Sweeny. Once I became consciously aware of my own self and behavioral patterns, more techniques were used on me in attempts to suppress what happened that night between that officer and me inside my home.

Years later after being severely re-traumatized by these covert activities performed on me and my life, I discovered that what I had experienced in my childhood in the 70's to the present was

unethical experimentation. Business associates had confirmed that these are new, unethical experimenters of government research projects and program.

During the time I was making claims that the former police officer sexually assaulted me, a strange man entered my life and befriended me long enough to sabotage my sexual assault case making false claims against me that he knew me before I was sexually assaulted. He claimed he had a back injury and a mental disorder from being a former governmental postal worker.

At the time I did not know the unethical research was working effectively on me and other experimentees. A brain/computer interface network is used to manipulate experimentees' home electrical systems so as to control our electronic devices and to remotely stimulate and manipulate our behavior with waves and beams. When listening to my radio and viewing the TV in my home, my body and its functions have been placed on a system network to work simultaneously with it without any interruptions. As a result in the summer of 2008, I was forced to hear a male voice describing exactly what I was doing while taking a bath.

The same exact thing had occurred when I was traveling to my former place of employment. My radio I was listening to inside my car was interrupted by a man calling my name, Amy.

During my employment with Inter-Con Security Systems, I observed hacking activities occurring on the state employees' computers at their work stations. I first started observing mouse pointers being used to manipulate scientists' desktops to access their files. I also thought it was odd and strange when making my rounds, and observing on printers, employees' bank statements left and not shredded. On several occasions I would also observe some employees' computers accessed when not present. When I reported these hacking activities to my former employer, Inter-Con Security Systems, I was suspended off the site and placed full-time into an unethical program to be harmed.

I was not given relief from these perpetrators harming my body with these mind-altering technologies until I had been placed on public record as displaying a mental disorder. This happened after I got tired of being harmed, and indirectly manipulated by these energies so I created a computer glitch over my phone after it had been manipulated to freeze up in the middle of surfing the internet.

The resulting computer glitch rerouted to Jonah R. Matranga and his business associates Holly Brook-Hafermann aka Skylar Grey and his daughter Hannah Matranga's satellite radio and TV network. I also have located their Google files they have created on me and my family members and other experimentees using this methodology nationwide.

One day a virus with a robot inside was downloaded to a video game to startle and frighten me which entered the display screen of my TV stating 'we are taking it over.' I did not know these individuals were referring to taking over my mind. I immediately unplugged my TV.

In October, 2011 I was completely removed off my place of employment as a security officer working inside the Department of Health Services after having discovered the identities of these individuals: Jonah R. Matranga, Holly Brook-Hafermann aka Skylar Grey and his daughter Hannah Matranga. I was deemed mentally ill and unstable per my medical records.

I started hearing sounds and energies used to interfere with the sensors inside my body. I was transmitting directed energy to stimulate my system in order to cause skin irritations. I began to feel burning sensations occur on the inside and outside of my body. These energies are used to cause my body to overheat due to blowing the whistle.

Since the time of my awareness as a nonconsensual experimentee, I received the attention and support from my city officials, Jovanka Beckles and Eduardo Martinez. They assisted me and other Richmond residents with their claims of human experimentation.

As a result, on May 19, 2015, Richmond City Councilmembers voted on and passed Resolution 50-15: To ban "space-based weapons and the use of weapons to damage persons or objects in its orbit..." The resolution "supports the Space Preservation Act and companion Space Preservation Treaty, to ensure that individuals will not be targets of space-based weapons."

I live in a senior park in east Mesa. This park is owned by Hometown America and I have been the third state that has taken this corporation in front of a judge for harassment. Stalking Issues:

- Noticed damage to outside plants dying
- neighbors on property
- neighbor with dogs used my property as a dog park
- damaged shrubs that had to be removed
- found diapers with feces and house sides smeared
- car fire in 2000
- dealership stated the hole in radiator was in unusual place
- Had dead battery (car doors open, had to watch during night) in mornings
- tires flattened
- two broken windshields in driveway. Saw neighbor and house guest on property in 3/2009 when I heard the crash. Reported to police and insurance paid for incidents.
- Started noticing another neighbor keying my house
- Incidents with air conditioner partially apart. Had police out and took 3 companies to correct the issue; insurance reimbursed. Met with management who did nothing.
- Had a private investigator put in a camera and did find video of home entry. Police saw tape and accused me of staging it. Have numerous police reports. When reported doors to home were open when returned from work. Police wrote reports but when they were obtained from Mesa police It stated I was an insane person.

I worked as a nurse for 53 years in six states and this was the only state that I had harassment of this nature and required police assistance.

I think the more serious issue is the harassment with devices. I noticed in 2002 I was receiving electric shocks, especially while sleeping and startled awake. A campaign of slander against me began also at that time by local Fairfield police and firemen, not to say this stalking and harassment was not seriously bad but compared to what I am also dealing with today it was mild in comparison.

The stalking, harassment and slander by Fairfield police and firemen got so bad I was forced to leave the city where I lived because of it.

Little did I know that leaving that city would not stop the stalking, harassment and slander by them. I did contact the local City Council and Mayor's office and the local newspaper in that

city but there was little that any could do about it because at that time I knew little about my perpetrators.

Fortunately, I found out 6 months later who exactly they were through various situations that unfolded.

They continued to stalk me from town to town with the intent of abducting me under a pretense of arrest for sex which was the main reason why they were stalking me in Fairfield California and I knew all about it.

I ended up in several cities, one of which ended up being San Diego, California, where not only the stalking and harassment by local police and firemen continued but their eventual recruitment of MILLIONS of people through a campaign of lies and slander that they were spreading about me all over the city and county of San Diego.

I was eventually stalked and mass-mobbed out of the city of San Diego by police and firemen, my perpetrator(s), and the local mass public that they had recruited.

My name is Jeannie. At my current location, there are over a dozen males that I and friends have witnessed on the property next door to the west of my property. Numerous directed energy blasts have come from that house at me and my residence. There is much activity in the garage, where heaps and heaps of pink insulation were brought in. I have personally seen numerous Caucasian males, two African-American, one Asian male and one Caucasian female. I have seen over a dozen persons in and around the property. A disabled man claims that he is the owner and a law student at Southwestern Law School. Attached (see flash drive) are a few of the recently taken photos. Sudden "work" on the next door "garage" began as soon as I moved into my residence next door, in the fall of last year, 2015. Currently, loud blasts have come from the house to the west and from the house two houses to the east.

I am stalked by persons in autos (more blatant stalking/harassment, for example four identical black Honda vehicles, five white cars, four ambulances within two hours, trucks that have tried to sideswipe me; had directed energy blasted at me when I exited supermarkets, stores, while entering and exiting parking lots while driving, blasts from cars approaching me and passing me. Blasts have also come from above. At a church picnic, a drone was flown over the picnic grounds near Beverly Hills.

I mention the CIA because I was once approached and offered a position as a spy when I was in Tokyo as a student, then an employee at a publishing company. I declined the position.

The types of persons that I have witnessed stalking are of various nationalities and do not appear to be your "usual, average, nice American citizen." Additionally, they easily crash my Internet searches, turn off Internet providers, and cellphone service. They are wasting their talents by harassing concerned US citizens instead of dealing with the real terrorists or perhaps they are doing what they are good at doing, being internal US terrorists. I was sequestered in a studio apartment in Mexico by my ex-husband Paco and finally got away. As I left I noticed it felt like I was being followed. I kept hearing "Ni Modo" over and over again by the people I passed on the ramp to cross the Tijuana border. This continued after crossing the border and followed me on the plane back to Florida.

I continued to be stalked and I noticed a conversation of several people including my ex-husband's voice audible only in my right ear. This went on off and on until half my filling of my composite suddenly fell out. I began to notice people swarming me wherever I went. Horns beeping every time I entered and exited my car or home. He blamed it on a relapse of the trauma I went through when I was attacked by Paco. I suspect my work was approached and some of my coworkers and clients, though I have no proof.

- my computer at home would all of sudden stop allowing me to access websites on stalking and remote neural monitoring or medicines that help treat radiation poisoning
- my email was being redirected before it went to the recipient.
- my computer for work started deleting files on its own of client information
- my personal belongings were being moved or stolen all together inside my home.
- I had a California AOL account get routed through AOL of Mexico when communicating with the Toxicologist who did a patch test confirming exposure to a Mycotoxin, nano liquid crystals embedded in my thorax, and copper poisoning.
- Even packages and mail appeared to be tampered with. Many purchased items would arrive defective, especially anything to do with the testing for toxins.

I was told my labs being out of balance for one organ and then becoming normal and this happening to different organs was a sign of radiation poisoning and this is when I agreed to have Dr. Staninger test for toxins and private investigator Melinda Kidder test for satellite terrorism. It may be coincidence, though I doubt it that these new experimental frequency allocations coincide with the RF your being hit with. That being said, I don't know how bandwidth is allocated by the FCC. There could be other satellites and communication networks operating in the frequencies you are being hit with. I think as more targets get the SCADA scans, we will start to be able to correlate commonalities versus coincidence.”

I had repeated visits to the emergency room for sudden nausea and severe vomiting. Not even water would stay down for days and I had to get an IV with saline on multiple occasions. Burns all over my body and a tan when I didn't even leave the apartment to get a suntan and sun burns for days and often for over a week.

I noticed a switch between hearing a conversation from now both of my ears to now hearing it in my brain. P.I. Melinda Kidder confirmed frequencies capable of producing V2K. I have experienced torture of 9/10 out of 10 for over 5,000 hours and lesser torture of 6 out of 10 for another 26,000 hours. Once the wound where the microchip was implanted was healed, my girlfriend Tracy started arguments over nothing until I left her and we split up for good. I had the feeling of always being watched, like I was being followed everywhere I went. The ringing in my ears began and has never ceased since the beginning. I started getting never-ending headaches and chest pains. Little did I know I was being microwaved with cancer-causing microwaves.

Then I started hearing my thoughts being repeated across like radiowaves blanketing the area where I lived and worked. People were cussing me out and humiliating me. No one at my place of employment or the neighborhood where I lived and worked would talk to me. People I didn't even know were threatening me. I lost job after job.

I moved back in with the mother of my children. My youngest was Little Manuel 3, Christina 5 and Richard 8. I did not know how my thoughts were being monitored but subconsciously I was being manipulated to kill my children, then their mother, then myself. The church elders of now Calvary Chapel and the church elder of New Song of Machado were full participants of the murder-suicide. They wanted to bury their not-so-secret microchip and persecution with the murder-suicide they were trying to psychologically manipulate me to commit. Then with then-mayor, tell the local municipalities to leave it alone. It was only a bunch of kids having fun that allowed anyone that participated in the psychological mental persecution, a free hand to do as they please, then and to this very day. Now Little Manuel is 29, Christina is 32, and Richard is 36.

Now I'm disabled from a motorcycle accident that I feel was staged by my perpetrators because I was getting too close to hiring an attorney. I was making even being persecuted 40,000 to 60,000 a year. Now I only make 1200 dollars a month on disability.

Also, they are still amusing themselves microwaving my body with severe headaches, severe muscle spasms, and attacking my leg muscles and joints so severely, it pains me to walk. Every time I think about wanting to go back to work, they attack me with their microwave weapons to where I can barely walk, punishing me to not think that I can ever go back to work. I feel it's a form of torture.

What kind of church elders allow their family members to target and torture innocent civilians? The churches in Lake Elsinore, California do; that's who. I was born under the Constitution of the United States of America. Now I live as a mental slave to the members of the gangstalking community of the city of Lake Elsinore, California.

Please look into the allegations I am trying to expose. This type of treatment and behavior does not belong in a free society, I feel like a mental [P.O.W.](#) in the silent civil war to reinstate the Constitution of the United States of America for all citizens within the Borders of the U.S.A. This should not be happening within a free society such as ours.

The names of the families that sponsored the illegal microchipping and still sponsor the mental persecution of my life are Brian as well as his adult children Helen, Debra, and Linda, Fred, as well as his adult children and even adult grandchildren who all work the field targeting me no matter which state I live in.

The mayor of the city of Lake Elsinore at the time of the planning and actual implementation of the microchip advised the Lake Elsinore City Police Department as well as the Riverside County Sheriff, Lake Elsinore Division to not intervene, that it was only a bunch of kids having fun. That made it legal to implant me and persecute my life as well as push me to suicide, a couple of years into my targeting.

My neighbor, Jess, had a heart attack arguing with his wife about her participation in the mental persecution I was enduring and died. His daughter, who was then and still is a Riverside County Sheriff Officer, vowed to persecute me until the day I died and is still an active member of the founding participants of the gangstalking activities that I am being victimized by.

This is what I think happened. They made sure every single family of the local residents that lived in the city of Lake Elsinore participated so no one could expose anyone else without implicating either themselves or members of their own families. That's how they keep their cloak of secrecy. But what happened throughout the years of my persecution is that some of them began joining the local churches while leaving some of their family members to carry on their gangstalking activities. Brian is a church elder located near where we all went to elementary school. His family as well as all the other families that had children that attended Machado Elementary School as children along with me were the families that formed and evolved into what I now call the gangstalking community of the city of Lake Elsinore, California.

Alan is another church elder who was a participant of the early gangstalking activities that I was victimized by. He is a church elder in Murrieta, California.

We as the victims of these types of crimes against humanity deserve justice as well as compensation for the mental atrocities. We have been victimized by the sadistic sense of humor by our perpetrators.

In the beginning there were well over 35 families that participated in pushing me to suicide. I figure there are still members from each of those families still participating in the gangstalking atrocities that I am being victimized by. To this very day please be advised that the names I have provided know the names of all active members as well as all inactive members that still participate when needed. They deserve to be brought before the courts as well. Please do not allow this injustice continue. This has taken almost my whole entire adult life. I pray someone can bring my living nightmare to an end.

I discovered I was being attacked with electronic, or directed energy weapons in August, 2015 at 36 years of age. I suddenly began experiencing a myriad of symptoms that are highly unusual and could not be attributable to typical physiological functions. Some of the symptoms I experienced were: sudden extreme sleep deprivation lasting 3-4 days straight with no sleep and leading to an ER visit, and continued severe sleep deprivation since then. Severe and prolonged suffocation episodes sometimes lasting for hours at a time and I read it is the electronic version of waterboarding.

I also receive voice to skull transmissions (V2K – a military term) with the individuals speaking to me insulting me for being female, (in an FFCHS survey it was found that 70% of victims targeted with directed energy weapons were women), and insulting me for being gay (which I actually am not gay), and constantly making threats on my life and health. They would constantly threaten to make me sick and die a slow, painful death from the results of their electronic weapons which were specifically targeted at various parts of my body including my head and internal organs, and which resulted in sudden significant GI symptoms including extreme constipation such that I could no longer produce a natural bowel movement causing significant distress. They caused severe, sharp chest pains and alterations in my heart rhythms with the voice transmissions threatening to cause a heart attack, among many other unusual symptoms. The voice transmissions were vulgar, highly perverse, insulting and constantly threatening and I received all attacks any time of day 24/7. I was made aware that I was under surveillance 24/7, violating my 4th amendment rights. The voice transmissions are highly disruptive, and psychologically traumatizing.

I received unusual, severe shocks, stings and extreme burning sensations in my face and limbs. They threatened constant pain, torture and suffering, they threatened the well being of

my family, and they constantly harassed me and commanded me to engage in unlawful activities that would cause harm to others which I always refused. With their electronic weapons they have induced unusual mental perceptions involving all senses, the obstruction of my normal thinking faculties including manipulating my memory and specific thought processes and they specifically aimed to disable my ability to work and enjoy life in any way. I am in the process of possibly losing my business and ability to work due to the electronic attacks constantly sabotaging me. I currently work in private practice as a speech therapist but I wanted to work for the public school system but I am not able to due to the attacks. The voice transmissions often do not allow me to pray and they heavily attack me sometimes when I go to church and tell me not to go, they insult my religious beliefs, etc., violating my 1st amendment rights.

They have remotely altered my electrical equipment to sometimes make it impossible or more difficult to record evidence and also to keep me from functioning at work so that I would not seek or keep employment. Since I became cognizant of the electronic attacks I have been enduring constant daily electronic sexual assaults day and night, nearly every day and sometimes for hours and hours screaming in agony, for the past 6 months. Many of these electronic sexual assaults lead to forced orgasms. The first night they started this they did forced orgasms one after another the entire night with no sleep and by morning I had developed a Parkinson's-like tremor on my chin due to severe Dopamine depletion due to excessive orgasms. These symptoms are clearly not naturally occurring normal physiological functions but rather the obvious manipulation of my mental and physiological functions by external electronically controlled classified technologies.

I will be getting formal scanning done on March 16 to identify the frequencies directed at me. Ever since I made the appointment I am getting attacked and tortured much more heavily physically and mentally with constant threats on my life and health with the voice transmissions explicitly threatening me. I won't be going to any of the appointments to collect evidence to pursue legal action. My attacks are so extremely severe I often fear for my life and feel forced to end my business and move in with my family soon.

I am a 44 year old female. I have a BSN in Nursing and have been a Registered Nurse and a financially independent professional for 22 years. I have been a homeowner for 14 years. I have no criminal record, no history of mental illness, no history of substance abuse or chronic

medical problems. I am not a threat to myself or others.

In June of 2012 I was violently and involuntarily initiated into a trauma-based mind control program that started off very suddenly and caused severe mental injury with PTSD and suicidal thoughts that persisted for years. The psychological abuse involved my community, neighbors, coworkers, parish members, doctors, first responders, family, and friends. I was completely blindsided as I never knew anything like this existed.

Within two weeks of the initiation of this programming, the severe psychological abuse culminated into a violent detention by 2 San Diego Police officers at my place of employment, KP Oncall, after coworkers called in a false police report on me. I was detained with excessive force at my desk in front of my whole office. No wrongdoing was ever witnessed by these 2 officers and I was never allowed to explain my side of the story. Both officers were young, inexperienced, and had pinpoint pupils as if they were under the influence of alcohol or opiates. This was reported to the Internal Affairs Dept. at the San Diego Police Dept.

I was detained under a 5150 hold in a locked psychiatric unit for 8 days where I experienced relentless psychological abuse from staff and patients, including my attending MD. Within 24 hours of the hold I was told I could leave, I opted to stay because I was barely able to eat or drink due to the severe psychological abuse I had already suffered.

After 3 months of outpatient therapy at Kaiser Permanente, which was required to return to work, I received psychiatric clearance to return to work. This program has destroyed all of my relationships and ability to trust anyone, including other victims. I have been stonewalled everywhere I have turned for help. Not only does law enforcement ignore this crime, many members exacerbate the abuse by participating in it, along with the cooperation of other first responders including fire departments and lifeguards.

I have personally witnessed appalling and widespread corruption over the past 4 years in every sector of my community, city, state and county related to this crime. Targeted individuals are trafficked electronically by this demonic network of criminals. I have personally witnessed these criminals engaging in all 8 "signs" the San Diego JTTF has listed for domestic terrorists. (<https://www.sandiego.gov/sites/default/files/legacy/ohs/pdf/8signsterrorism.pdf>).

Earlier this year I attended the meeting with the agent from the LA FBI office and gave him a file that contained additional testimony. I would also like to give you a link to my blog, specifically <https://stoporgangstalking.com/2013/06/16/organized-gang-stalking-electronic-harassment-is/> which details the specifics of the abuse targeted individuals receive on a daily basis.

The recent Erin Andrews case is just the tip of the iceberg when it comes to the damage these criminals do to innocent people's lives. I am overtly ogled daily by males who make it very clear to me they have seen videos, photos, and memes taken of me during my most personal moments inside my home. This program is the mental equivalent of a slow, never ending gang rape. Which is why so many victims commit suicide, murders, or both. You are seeing them on

the news every day now.

Many factors in society and technology have come about and come together in a "perfect storm" to cause trauma based mind control programming to be so prevalent now. The popularity of "rent a crowds" globally is just one piece of what makes the organized stalking feasible. I am not anti-government. I am a firm believer in law and order. My Dad was a physician and served in the USN during the Korean War. My uncle John Gallagher was a WW2 veteran and was an SA in the FBI in New York City. I do think there are many corrupt individuals in the USG, or posing as fraudulent members of the USG, that are involved in this heinous crime. I do not understand their motivations. From what I have personally witnessed it is pure evil. Their psychopathy is that of serial killers.

Myself and thousands of others were blindsided by this criminal program. For thousands of targets it is already too late. Many others have been victimized for decades now. All we want is our lives and freedom back; our reputations, and civil/ constitutional/ human rights restored. No one deserves to be treated like this and so many of us are truly innocent. There are many things the executive branch can do to help us if you will just lend us an ear and take us seriously. Many new laws are needed to address this problem, but so many have already been broken without any justice despite our desperate attempts.

I am providing this letter as a general statement about my experience as a targeted individual of electronic harassment and organized stalking. I have been the target of individuals who have committed crimes that include invasion of privacy, violation of constitutional rights, verbal and physical, threats against my life, criminal damage to property, breaking and entering and assault with various electronic radio frequency devices and more. I was a twenty-five year resident and homeowner at a southeast Scottsdale, Arizona condominium community where most of the harassment had taken place.

First, I would like to say that this form of harassment is both unique and, for most of the people and agencies that I had sought help from, difficult to believe. I will not provide many details about the effects of the devices that had been used to harass me in this letter but, I would be willing to provide more detailed information if requested by the proper authorities.

The harassment had begun some time ago and included verbal threats that came from outside my home and from a common flat roof that I share with two or more persons who were involved in the harassment. Other tactics used included vandalism of my home and vehicle. Liquids such as ammonia; kerosene and lighter fluid were poured into the roof vents of my home along with threats of burning me alive if I didn't move out of Scottsdale. Twice in two years a gun was fired outside my home. This happened in a neighborhood where this kind of thing had never happened before. The most constant form of harassment and torture that had been used against me was to amplify their voices through the common wall and ceiling crawl space of my condo. Other unusual devices used to harass me in my home and at other locations are electronic weapons based on GPR Ground Penetrating Radar and microwave radio transmitters. A search for electronic weapons on the inter-net will show that these radio frequency devices are available for sale in kit form to anyone willing to pay the price.

I know that the use of radio frequency technology as a tool of harassment is widely unknown in both civilian and law enforcement communities, but that should in no way diminish the crimes committed by the use of this technology against American citizens. There are companies that manufacture Rescue GPR devices and the following web address will attest to the fact that these devices do exist. Please refer to this site to confirm that ground-penetrating radar for rescue services and that through the wall imaging devices for police and military operations are available. (<https://sensoft.ca/Products/Rescue-Radar/Overview.aspx>) I have included another web site that explains how other types of electronic harassment devices can be made from existing civilian technology. http://www.bugsweeps.com/info/electronic_harassment.html.

I attempted to get help from the Scottsdale Police Department to end the harassment and their response was to place me in to the Maricopa County Mental Health Hospital for a psychological evaluation. After seven days and a psychological test I was released. The test indicated that there was no sign of mental illness. I have never had a history of mental health problems and until I was ordered to have an evaluation I had never had a mental health evaluation.

In the spring of 2012 another tactic was added to the harassment. In June the police were called when I got on the roof to check the fuses on my air conditioner when it lost power. The police were called several times because of a noise in my condo. The police were called again when it was alleged that I threw something on my roof. The police were called when I watered my bushes in front of my home. In all of the complaints listed above and more the Scottsdale Police did respond and in some cases I was told to stop bothering the neighbors. During a seven-month period between April and December of 2012 there were several calls placed to the Scottsdale Police regarding mundane things that had nothing to do with violations of the law. I lived in my condo for twenty-five years and during that time I had never had a problem with neighbors or the police.

On December 7, 2012 at 9:30 p.m. I had returned home and a man shouted from outside my condo to "come outside let's get this over with!" I went outside with a flashlight and stood in front of my condo and one of the neighbors from the north side of my condo and a woman walked around the corner of my unit and we stood about twenty feet apart. He asked what I was doing and I asked the same question. He came at me with his fist held up and I raised my free arm across my chest in a defensive manner. He stopped turned and said that he was going to call the police. Ten minutes later several Scottsdale Police cars, dogs and officers with automatic weapons were outside my home. I was arrested and charged with assaulting the two people. I spent seven days in the county jail and then I was released. On Dec 14 the county dropped the case.

During the previous eight months before Dec 7, 2012 I had experienced problems with my power and I was in the process of testing the circuits when I was arrested. After my release from jail, I returned home to find that my power had been disconnected by the City of Scottsdale. After I contacted the power company and the city building permits office I was informed that the electrical wiring in my condo was completely out of code. I was told that I could not have my power restored until I had brought the electrical wiring up to code. I purchased the condo new so the building permits department's requirement was not necessary. I lived without power for five months. The city building permits department finally agreed to restore the power after I had an electrician check the wiring and re-wire the outlets and light switches.

In June of 2014 I was forced to sell my condo when the HOA refused to accept a \$2700.00 payment in full for late dues. Then the Scottsdale Trails HOA attorney began the process for eviction and added an additional \$6000.00 to the debt.

I am now renting a mobile home in Mesa AZ. The people from the group that harassed me at Scottsdale Trails followed me to my new address and despite the age specific requirement in the community, the harassers have managed to move in this community. Recently I have discovered that the electricity in the mobile home that I had rented has been manipulated and stolen at the service box. The electrical wiring had been manipulated in a similar manner as it was at the Scottsdale Trails address. I also recently found that the electrical wiring in my vehicle a Nissan Pathfinder had been re-wired and what appears to be an electronic switchers with remote control capabilities had been installed. The wiring that has been almost completely altered appears to be routed through at least three switchers. I suspect that such functions as the taillights break lights alternator, air conditioner, ignition and vacuum valves can be controlled. I am in the process of identifying the rest of the electronics. I recently discovered that one side of the front bumper is no longer attached to the frame so I decided to continue to inspect the vehicle for more manipulation. I found that the air bag in the steering wheel has been removed and the carrier bearing between the transmission and the rear differential had been removed disabling the vehicle. I suspect that the alterations and added electronics to my vehicle had been done to cause an accident and injury to myself. I filed a vandalism report with the Mesa Police Department and I reported the damage to Geico Insurance Company. The Geico claims adjuster had the vehicle towed to a "Geico guaranteed body and repair shop in

Mesa and was told that the shop didn't want to work on the vehicle because they couldn't guarantee the work. The vehicle was towed to a Nissan dealer in Chandler Arizona and the adjuster was told that they would not touch the vehicle. Presently I am waiting for Geico and the adjuster to decide on how to have the evidence removed and the electrical wiring repaired.

The Scottsdale Police were not only aware of the harassment for several years, they were also aware of the manipulation of the electrical wiring in the condo. They had witnessed the harassment and on more than one occasion they had spoken to the people involved. The Scottsdale Police have information about the people involved in the harassment and the criminal damage that had been done to my condo wiring. To this day, I have not been contacted by the Scottsdale Police and I have not been contacted by the Scottsdale City Prosecutor regarding information they may have about the harassment. To this day I am not aware of any arrest of any one who had been involved in the harassment in Scottsdale.

Harassment can take many forms and in my case harassment has taken some unusual and difficult to prove forms. However, the wiring in the Scottsdale Trails condo unit number 1057 and my present address at Windsor Park 150 S Windsor B16 Mesa AZ, should be evidence of the harassment and should at least be cause to start an investigation. As a result of these events and the electronic harassment, my life has been disrupted and my financial stability has suffered. To this day the harassment has continued and I will continue to seek help in getting justice by prosecuting the criminals.

“End the Torment!” were the words scratched onto Aaron Alexis’ Remington 870 shotgun during the September 16, 2013 massacre that left 12 innocent people and the shooter dead at the Washington Navy Yard. A little more than a month prior to that tragic event, on the morning of August 7, 2013, 34-year old Alexis called the Newport, Rhode Island police and reported being stalked and assaulted in his hotel room. He told responding officers he felt threatened and had moved to three different hotels in the Newport area to escape the tormentors. He believed they were assaulting him from adjacent hotel rooms using some type of “microwave machine.” He was feeling “vibrations through his body” and “hearing voices” that would not allow him to sleep. On September 1, 2013, Alexis emailed a support group, *Freedom from Covert Harassment and Surveillance*, and said, “Need assistance on dealing with the direct energy attacks!!” Alexis believed he was under technological attack.

Seventeen days after the Alexis incident, on October 3, 2013, Miriam Carey, a 34-year old dental hygienist from Stamford, Connecticut, drove to the White House with her 13-month old daughter and was shot and killed near the Capitol after fleeing a White House checkpoint. According to multiple 911 calls to the Stamford Police Department in November and December 2012, Carey believed she was being stalked and videotaped in her condo. She also believed President Obama was communicating with her and had put her residence under electronic surveillance. Miriam Carey was also hearing voices. Less than a year later, something caused her to drive 270 miles to the White House on that fateful October day.

Investigating officials and the media immediately suggested both tragedies were the result of mental illness. I do not believe that to be the case. I believe criminals with access to lethal technology pushed Alexis and Carey over the edge with complete disregard for innocent lives. To my knowledge, that possibility was never thoroughly investigated.

Thousands of people across the country are “hearing voices.” Many think they are being targeted by satellite technology capable of reading their thoughts, transmitting sounds and voices directly into their brains, and physically assaulting them with microwave energy. This technology is impossible to comprehend without experiencing it. Most people, including law enforcement, the media and the mental health profession, seem to be completely oblivious to this critical situation.

Victims experience something similar to having harassing talk-radio beamed directly into their brains 24/7 with no control over its content or volume. It is an extremely severe form of psychological torture that incapacitates people and destroys lives. Microwave energy is used to physically torture victims by creating pains on their bodies and in their ears, brains and internal

organs. Through this physical and psychological torture, they push people to suicide and violence and put innocent lives at risk in the process.

These criminals violate an untold number of existing and yet to be defined laws, trample our Constitutional rights, reject international conventions and ignore every principle of human dignity and privacy. This is domestic terrorism, torture and a “crime against humanity”, and could ultimately prove to be one of the largest crimes in U.S. history.

Technology of this magnitude was likely developed over decades at enormous cost by the U.S. government. The government would presumably secure this technology, understanding its power to become a “technological nuclear bomb.” If obtained by a hostile government or terrorists, it could be used against anyone, including our own leaders, and could pose a serious national security threat.

The U.S. military has been researching microwave technology and possible applications, including “microwave hearing”, for decades. Simple microwave communication was possible 40 years ago. A 1975 article in *American Psychologist* titled “Microwaves and Behavior” by Don Justesen stated “appropriate modulation of microwave energy can result in direct ‘wireless’ and ‘receiverless’ communication of speech.”

A 1998 Department of the Army report “Bioeffects of Selected Nonlethal Weapons”, declassified in 2006, states, “Application of microwave hearing technology could facilitate a private message transmission. It may be useful to provide a disruptive condition to a person not aware of the technology. Not only might it be disruptive to the sense of hearing, it could be psychologically devastating if one suddenly heard voices within one’s head.”

A quick internet search for “mind-reading technology” listed articles from The Economist, NPR, Huffington Post, Scientific American, Wired, Newsmax, Detroit Free Press, and The Guardian, among others. All speak to neuroscientists’ ability to decode human thought by analyzing brain activity. Non-verbal speech and lie detection are just two of the identified uses. Topics such as brain-computer interface, brain imaging, electrocorticography (ECoG), functional MRI (fMRI), and synthetic telepathy are also discussed. Mind-reading technology clearly exists, and according to numerous accounts, it has advanced well beyond what is publicly known.

I know this to be the case. Before sharing my personal story, I want to provide a quick overview of my background. I am 48 years old and have owned my own real estate investment and development business in the Denver area since 2001. Prior to starting my own business, I worked for Wall Street investment banks in Houston, Los Angeles and New York for roughly a decade. In my last position, I managed a \$100 million real estate fund for Daiwa Securities in New York.

I was an All-State baseball player in high school and an Academic All-American at the University of Texas. I was drafted by the Texas Rangers and played one season of minor league baseball

before starting my business career. I have never been involved in any criminal activity and have never used illegal drugs. My personal relationships and business career were built on trust and integrity.

I do not have the benefit of fully understanding many of the things discussed in this paper, however, I have tried to present the following account as honestly and accurately as possible. While I will certainly gain additional clarity as the situation evolves, this paper is completely true and factual with respect to what I know today.

I have been an organized stalking victim since early 2005, although I did not discover the term until about a year and a half ago. I have been followed, monitored and harassed and have experienced multiple acts of vandalism, break-ins and theft. The crimes have occurred throughout Colorado and in several other states. The stalkers have completely stolen my privacy, and for many years, created a constant state of fear and anxiety. The impact on my life and psyche has been extremely severe.

Like many organized stalking victims, I still do not know who is responsible or why I was targeted, but a large, coordinated, well-funded group is involved. I have contacted local law enforcement and the FBI, yet the stalking and harassment continued. In fact, things escalated last year.

In the spring of 2013, I started hearing unusual noises on my property, such as banging, clanking and clicking sounds in the attic and around the house, and what sounded like people walking on the roof and in the attic. I also heard moaning and groaning sex sounds. At first, I thought someone had installed some type of hidden audio system in the walls and ceiling to bring the harassment campaign into my bedroom. I could not make sense of it. Shortly thereafter, I began "hearing voices."

The perpetrators kept me from sleeping by creating noises, narrating false dialogue and scenarios, subjecting me to all-night intense interrogations, and tormenting me with pains caused by microwave energy. They wanted to completely break me down physically and emotionally and make me believe my life was constantly in danger. They narrated fake shooting scenes, hideous rapes and countless other threatening scenarios.

For several months, they said there were former Navy SEALs hiding out on my 70-acre, densely wooded property. Just before daybreak in early August 2013, after one of the all-night interrogation sessions, I felt a tingling sensation on the back of my head while lying in bed. A voice said it was a rifle scope locked on my head from outside the house. He told me to "get out of bed, now, now!" I thought I was under attack. I grabbed my shotgun and headed to the basement.

While sitting on the basement steps with the shotgun on my lap, I heard what sounded like several volleys of assault rifle fire coming from the dense scrub oak beyond the driveway.

Shortly after the gunfire, the voice said a renegade SEAL had moved out of the brush, down to the front porch, and was going to kick in the front door. They told me to “shoot the wall, shoot the wall, shoot now!” Fortunately, I did not shoot, and shortly thereafter the voices said they had gotten “control of the situation.” While this scenario felt life-threatening at the time, I now know it was one of their many attempts to scare and provoke me.

They changed the dialogue and narrative to fit my surroundings at three houses in Colorado, my mom’s and brother’s houses in Oklahoma and a friend’s apartment in Texas. While staying at each location, fictitious voices and scenarios were used, involving six different sets of neighbors. In each instance, the neighbors were supposedly creating the threatening dialogue and assaulting me with “microwave energy.” Their intent was to provoke me to confront innocent people and to cause me to make unprovable claims to family, friends and law enforcement. This is how the technology is used to destroy victims’ credibility and make them appear disconnected with reality and mentally unstable.

My Douglas County neighbors were supposedly ex-CIA and former Navy intelligence and coordinated the torture campaign on my property. From their backgrounds, they had access to “electromagnetic weapons”, “microwave weapons” and “ultrasound weapons.” They suggested a prominent Coloradan, allegedly involved in narcotics trafficking, paid my neighbors “\$500,000” to conduct this campaign with the complicity of a senior FBI official. They said they wanted to destroy my credibility, create an “actionable event” and “push me to suicide” for “making too much noise” regarding the Colorado system.

At my dad’s house, it was supposedly his neighbor “across the courtyard” and someone “in the field” adjacent to his house assaulting me with energy. At my mountain home, it was a neighbor living in a house behind mine who was responsible for the “electromagnetic weapon” assault.

Shortly after arriving at my mom’s house in mid-October 2013, they started a threatening dialogue using a voice that was supposed to be her next door neighbor. He was an “eighth degree black belt in taekwondo” and was threatening to “kick in the front door” to get us. They continued depriving me of sleep with computerized interrogation programs “jointly controlled by the FBI and Warren Buffett’s satellite operators.”

The Tulsa FBI supposedly had a surveillance team staying in a house across the pond from my mom’s house. They were hitting me with “electromagnetic weapons” and “microwave weapons” and creating the pains on my body while I was trying to sleep. When my dog developed a hot spot on his tail, they said it was caused by an “FBI agent tasing him.” A powerful laser beam or “satellite death ray” created the pressure on my heart and the stinging in my eyes, and according to their threats, could “pierce my heart or blind me.” They said it was responsible for numerous reported heart attacks.

While sitting on my brother's lake house deck with my mom, they created a sharp pain in the middle of my chest and said they were hitting me with an "electromagnetic weapon" from a mile or so across the lake. They claimed it was a "military weapon that can stop a person's heart from seven miles away."

At my friend's apartment in Dallas, her upstairs neighbor was a "confidential informant for the FBI" and involved in this multi-state plot to torment me. He and his son were supposedly "video recording us through the ceiling", making the constant lewd remarks and assaulting my dog and me with an "electromagnetic weapon." They obviously wanted me to believe there were co-conspirators in every state, city and neighborhood who would keep me from ever finding peace.

Many other victims report being assaulted by energy weapons. To my knowledge, none of these weapons have ever been found and no one has been arrested in connection with this type of assault. Yes, we are being assaulted by microwave energy, but it is being done remotely via satellite. These attacks do not require a local, neighborhood presence. A relatively small number of individuals are likely sitting in secure facilities, targeting people across the country. This is more efficient and allows them to operate in secrecy.

Over time, the intense all-night interrogation/torture campaign began to transition to some meaningful dialogue. They said I had been connected to a satellite surveillance system, controlled by a highly sophisticated computer network. The computer contains extensive information and voice-replication capabilities for many people, including family, friends, neighbors and business and personal contacts. This information and the emulated voices are used to create fictitious dialogue and scenarios customized for targets' specific relationships, circumstances and surroundings. The system operators are essentially voice actors, narrating radio skits to humiliate, intimidate, threaten and provoke victims.

The operators have also used the names and voices of prominent individuals such as President Obama, former President George W. Bush, Zbigniew Brzezinski, Warren Buffett, Bill Gates, Governor Hickenlooper, Phil Anschutz, Christian Anschutz and Pete Coors. Some of these names have been mentioned hundreds of times over the past year.

Over the past year, many different explanations have been given for my predicament. Some are as follows. It all started due to a "pay to play" extortion scheme by certain members of the Colorado real estate community. They were trying to collect payment prior to closing my first big deal in Colorado in June 2005. The organized stalking campaign has been conducted by members of the massive Homeland Security apparatus with ties to organized crime and a government control system. I was put on some type of Homeland Security "watch list" for punitive reasons by a powerful person within the system.

They talked extensively about a “sex system” in which women are compensated for providing sexual services with “drugs and drug money” and “sex credits”, and a “pay system” controlled by the “New York mafia.” Both offer financial rewards and “personal protection.” They have said I was required to pay an amount ranging from “\$500,000” to “\$10 million” or “earn my way by participating in the sex system.” The long stalking/torture campaign supposedly resulted from being “out of sync with the system” and “making too much noise.”

For months, the perpetrators said I was connected to a “satellite communication network” through an “implanted microchip.” However, they could never identify the specific type or exact location of this microchip. Google/Motorola supposedly manufactured it. Initially, they said it was a “synthetic telepathy microchip” implanted by a former business colleague “in the back of my neck.” After nothing was identified on a neck x-ray, they changed their story and said the chip was implanted “in my upper back between the shoulder blades.” They also said it might be a “cochlear implant” or possibly tiny “nanochips in my inner ear.” Their final narrative suggested it was a “modified VeriChip, secretly manufactured for the CIA, implanted in my shoulder.” Their narrative continually changed and the mysterious microchip kept moving around in my body. Needless to say, I never found a microchip.

The microchip narrative seems to be prevalent with targeted individuals. The perpetrators take advantage of the fact this technology is easier to accept with an implanted device. For a long time, they were able to convince me a microchip was required to track, monitor and communicate with me everywhere - residences, office buildings, the mall, grocery stores, restaurants, parks and fields, and on roads and highways driving across three states. The connection is unfortunately stronger and much more reliable than my cell phone. While the volume has been adjusted frequently, the connection has never faltered.

I am now convinced microchips are not involved. The microchip narrative would require a manufacturer, national distribution and a highly risky, covert, implantation campaign. It would also require a large medical and mental health conspiracy to block their discovery. With thousands of people picking up microwave communication, no one is finding microchips.

Actually that is not entirely true. I was able to find information on two people who found implanted microchips – James Walbert in Wichita, Kansas and Bob Boyce in Blue Ridge, Georgia. I was unable to confirm if either of them had been hearing communication or if their microchip removals stopped it.

To my knowledge, the only microchip approved for human implantation is the VeriChip. It is used for accessing patients’ medical records. According to VeriTeq, the successor entity, there are no facilities offering their microchips or scanners in Colorado. I do not think Veriteq or anyone else is involved in a massive government conspiracy to have everyone implanted with microchips.

The microchip narrative is part of a vast disinformation campaign. It distracts, discredits and discourages victims who are unable to locate an implanted device. MRIs, CT scans and X-rays are expensive. Many targeted individuals cannot afford to scan their entire body searching for a microchip. Those creating the microchip narratives know this.

For those questioning how “voices” can push someone over the edge, this is important. The people controlling this technology are highly believable at first. They break victims down through sleep deprivation and intense physical and psychological torture. Exhausted, disoriented and just trying to survive the torture, victims are extremely vulnerable to anything, including false narratives, that might offer an explanation for their unimaginable pain and suffering. I experienced it firsthand. Fortunately, I made it through the initial onslaught, and by doing so, became conditioned to these tactics.

It is also important to note that sleep deprivation is a very serious form of physical and psychological torture banned by the Constitution, the United Nations, the Geneva Conventions and the International Criminal Court. It has been used as an interrogation, torture technique throughout history to break people down and extract information.

Menachem Begin, former Israeli prime minister, was sleep deprived and tortured by the KGB. In his book, *White Nights: The Story of a Prisoner in Russia*, he states, “In the head of the interrogated prisoner, a haze begins to form. His spirit is wearied to death, his legs are unsteady, and he has one sole desire: to sleep...Anyone who has experienced this desire knows that not even hunger and thirst are comparable with it.”

Victims of technological assault are not just having a tough time sleeping. They are being brutally tortured through sleep deprivation.

The perpetrators have indicated the connection to my brain not only allows them to read my thoughts, but also literally see what I see. As you would expect, this has completely destroyed my sense of privacy and made it impossible to lead a normal life. They have made thousands of lewd, derogatory and insulting remarks while in the restroom or taking a shower, lying in bed at night, and even during times of intimacy. It has included comments about my genitalia, my sex life, masturbation and my most private thoughts. They have also repeated passwords and pin codes, discussed medical information, and monitored and recorded my business and personal activities.

The privacy violations are truly unimaginable. Some refer to this unauthorized, forced access into peoples’ brains as “mind rape.” This term describes the egregiousness of the violation, yet the law does not even contemplate this despicable crime.

These cowardly criminals have continually told me they want me to commit suicide, and have tried every tactic at their disposal to see if they could push me to that point. After months of torture, they now acknowledge suicide is not a possibility.

They can supposedly determine peoples' susceptibility to suicide or violence from their thoughts. They have claimed, seemingly without remorse, that they have caused thousands of suicides. Whether true or not, they have also said this technology was used against Aaron Alexis and Miriam Carey.

In addition to communication, many victims also experience physical symptoms from microwave assault. I have personally experienced the following: feeling something similar to a mild electrical current on my head and body, loud ear ringing, intense pressure on my ear drums, shaking, vibrating sensations, eye stinging, un-flushable eye irritation, severe eye strain and red, swollen eyelids, pains on and in the brain, sharp stomach pains, upset stomach, chest pains, heart palpitations, inexplicable shortness of breath, stinging, burning, tingling and pin-prick sensations all over my body, uncontrollable itches, scratchy throat, severe chills, dehydration, frequent urination, constant nasal drain, and penis stimulation/de-stimulation.

It is not clear if the physical symptoms are caused by energy being directed at specific areas of the body or by the technology's interaction with the brain. The perpetrators create and adjust the intensity of these symptoms and have remarked and even joked about doing so. For months, the perpetrators constantly tormented me with physical pains and sensations while leaving a computer bouncing interrogation programs off my brain all night, completely depriving me of sleep. This is a severe form of torture.

I have felt extremely intense pressure on my internal organs, as if they were going to explode, while they talked about "cranking up the energy." The pain was severe enough to push me out of the house several times. I experienced eye irritation comparable to having dirt in my eyes, but was unable to wash it out. They bragged about "eye irritation" being one of the "functions." They put extreme pressure on my inner ears and talked about "blowing out my eardrums." They can somehow make it difficult to get an erection and have threatened to cause permanent erectile dysfunction. They even applied severe pressure on my heart that could have been mistaken for a heart attack under different circumstances. They wanted me to believe they could pierce my heart and kill me at any time.

During nights of constant chatter and microwave bombardment, I urinated excessively (10-15 times over an eight-hour period), became dehydrated and experienced severe chills. I wore sweat pants, a fleece top, socks and a stocking hat to bed many nights, yet shivered uncontrollably. This was not caused by auditory hallucinations. It was caused by intense microwave exposure.

The U.S. government has studied the health effects of microwave irradiation for at least half a century. Starting in the 1950's, the U.S. Embassy in Moscow was subjected to Soviet microwave bombardment during much of the cold war. While a detailed medical discussion is beyond the scope of this paper, it is important to note that microwave exposure can cause

numerous health issues, including brain cancer, leukemia, strokes, heart disease, immune system disorders, infertility, birth defects, vision problems, cataracts, headaches, insomnia, depression and anxiety.

They have maintained a constant microwave connection to my brain for the past year with absolute disregard for the health consequences. Presumably, this is the case with countless other victims. American citizens are being invisibly assaulted by a very dangerous weapon and nobody is paying attention.

Once an individual's connection has been established, the physical symptoms can be induced without sound or communication - on "mute" so to speak. If true, it would allow them to create headaches, tinnitus, erectile dysfunction, depression, anxiety and other pains and ailments, and even simulate heart attacks, completely undetected. There are likely many individuals who have never heard a sound or voice, and are therefore, completely unaware they have been targeted. That significantly changes the scope of the problem.

The computer that controls the link can read my mind and respond with instantaneous dialogue based upon my thoughts. It is constantly collecting information from my brain. The technology enables the operators to determine whether or not someone is telling the truth. This would obviously be extremely valuable in the interrogation of criminals and terrorists, which might be the rationale under which it was developed. However, there are obvious constitutional issues that must be addressed before using this technology on the most dangerous criminals, let alone law-abiding citizens.

The operators can push, or "suggest" as they call it, words, thoughts and images into peoples' brains. Some refer to this as "mind control." At times, they direct unwanted sexual images and uncomfortable thoughts into my mind, often with laughter in the background. However, they also suggest various foods, activities and other things that serve as reminders. From my experience, it is not "mind control", because I am able to choose whether or not to accept the suggestions.

During some days, the dialogue has been nearly continuous, with computerized voices responding to or commenting on virtually every thought and activity. On other days, it has been relatively quiet. The volume can be adjusted from silent to loud and clear. I have recorded many hours of communication by repeating what I am hearing verbatim. The pace of the communication is much slower than normal conversation, with gaps between words or sentences, presumably due to satellite transmission delays.

The system lingo includes phrases such as "young whippersnapper", "since I was knee-high to a grasshopper", "bunch of big mother fuckers running around", "don't get above your raisin", "kick your teeth down your fucking throat", "on the planet", "in the universe", "put a gun in that pretty little face", "since time immemorial", "thrown under a bus", "that's unbelievable

testimony”, “in my entire human existence”, and “I’m not your best friend but I’m not your worst enemy.” These are not phrases I have ever used.

Whoever runs the system has somehow justified having multiple people tied into my connection 24/7 since it was established. They sound like intelligent, educated professionals, not uneducated criminals. The communication is articulate and often includes witty, impromptu remarks. While they occasionally use female voices, I believe they are all men. As ridiculous as it sounds, they actually correct my grammar and offer personal and business advice. The people and the crimes seem incongruent. Some of them acknowledge this and say they want to expose it.

They have said they are a small group of six-figure, NSA, CIA and FBI employees with top secret clearance. They supposedly represent the pay and sex systems and execute various assignments for system big shots. One can imagine the ways in which the technology is being used – political blackmail, intellectual property theft, insider trading, etc.

My energy and level of distraction fluctuates with the amount and volume of communication. I have had difficulty working, or even reading or watching a movie, since the communication began. My ability to run a business or to enjoy two of my favorite activities has been taken away. It has had a profound impact on every aspect of my life. For many victims, earning a living or leading a normal life becomes virtually impossible. Sadly, this is the intent.

The satellite operators have stopped transmission briefly on several occasions causing unbelievable, instantaneous relief. I have felt the pressure and strain immediately wash from my head, face and neck as the microwave energy dissipates. I could literally feel the energy draining from my head. The best analogy is the cooling sensation when stepping out of a sauna.

People that report being stalked and monitored or “hearing voices” are often diagnosed with mental illness. Unfortunately, there is not yet another widely accepted explanation. Technology of this magnitude is extremely difficult to comprehend and there is currently very little credible, publicly available information.

We very much need the assistance of the mental health profession. They are the only ones with access to decades of specific patient experiences. I have not yet found anything that summarizes or analyzes these records to determine if there might be patterns or trends associated with people “hearing voices.” How many patients who have become part of the mental health system, voluntarily or otherwise, are victims of organized stalking or technological assault? The mental health profession may hold the “smoking gun.”

Many questions need to be raised. What messages are patients hearing? Are they derogatory or threatening? Do victims feel they are being stalked or monitored? How many voices do they hear? How long do they hear them? Does the volume change? Are physical pains and

sensations experienced? Do they think some type of energy may be involved? Do the voices sound computerized? Are unique words or phrases used? Do they hear famous peoples' voices? Is the pace of communication conversational or are there gaps and delays? Do they believe their minds or thoughts are being read? Is there a focus on topics that make them feel guilty or uncomfortable? How often are they told to commit suicide or harm others? How often do medications work? Is it possible medications provide cover to stop the communication?

To my knowledge, the only possible defense against this assault is to block microwave transmission. Protective clothing and homemade Faraday cages will not work. Advanced materials and professional construction are required. A few companies that could potentially construct such a facility are ETS Lindgren, Cuming-Lehman Chambers and Braden Shielding. They use terms such as anechoic chambers, shielded rooms, screened rooms and microwave chambers. If possible, we need to locate government or corporate facilities willing to grant access so we can prove microwave energy is responsible.

For those wanting to learn more about organized stalking and technological assault, there are many websites, blogs, articles and books available. Mark Rich's book, *The Hidden Evil*, offers an historical overview of control systems, such as communist East Germany's secret police, or Stasi, and its reliance upon a massive informant network and organized stalking. Dr. John Hall's *A New Breed, Satellite Terrorism in America* provides a detailed account of his personal experience with organized stalking and satellite assault in San Antonio, Texas. Jesse Ventura's TruTV *Conspiracy Theory* series examined the issue of people hearing voices in their December 2012 "Brain Invaders" episode. They concluded military communication towers, Ground Wave Emergency Network (GWEN), were being used to target victims with microwave energy. KMIR News in Palm Springs, California reported on "hundreds of people in the valley hearing voices" in November 2012. The video, which includes interviews with several targeted individuals, is available at <http://www.jrn.com/kmir6/news/179055911.html>.

According to their website (www.freedomfchs.com), "Freedom from Covert Harassment and Surveillance is a human rights organization that identifies and networks with victims of organized stalking and electronic assaults, educates society about covert harassment issues, and advocates for citizens victimized by covert criminal elements." They network with and provide support for victims throughout the U.S. and worldwide. They organize meetings across the country, host daily conference calls, publish a weekly newsletter and provide a toll free number for victims.

Having worked on this issue for the past decade, Derrick Robinson, President of FFCHS, has become a prominent leader in the fight against organized stalking and technological assault. He offered the following, "Aaron Alexis represents a lightning-rod for our issues because of the notoriety of his action, the Washington Navy Yard shooting, and because he had contacted us

(FFCHS) two weeks prior to the shooting exhibiting many of the same effects that are common in our community, such as microwave attacks, hearing voices, sleeplessness, and the group stalking scenarios. And although we do not condone Aaron's solution, he highlights an extremely important human rights issue in this country which is being suppressed and for which there is currently no recognition or remedy."

"Our community is continually amazed at how large a secret can remain undetected by our society for so long. It has often been discouraging. However, I believe there will come a day – and probably soon – when this entire criminal network which now operates in secret will become common knowledge to everyone and covert targeting and secret tortures will all be over."

I would like to offer a few suggestions for victims based upon my personal experience. Most importantly, hang in there! We will identify the perpetrators and stop this torture. Record what you are hearing and experiencing. Those recordings will help us validate and share our experiences and will prove valuable in future legal proceedings. We will eventually have our day in court.

Let the perpetrators know you are familiar with their tactics of false narratives, derogatory remarks and threats. Ask questions that might help you gather information. For those of you that do not know why you were targeted, you are not alone. Many of us are still trying to figure it out. Like most powerful weapons, criminals will use them for many different reasons, and sometimes, for no reason at all.

Finally, help us spread the word. We need as many people as possible talking about this issue, asking questions and looking for answers. These criminals are accustomed to operating in the dark. We need to push aggressively to expose their crimes.

My experience with organized stalking and technological assault has already stolen nine years, or roughly one-third of my adult life. It has irreversibly altered the course of my life and potentially damaged my health in ways not yet apparent.

Without intervention, countless other victims will be exposed. Some will not be able to endure the torture, and acting from a place of desperation, they will take their own or others' lives. Their breaking point could be reached at any time. Until we get control of this technology, it is impossible to predict the next tragedy. This is a national public safety emergency!

We desperately need the assistance of law enforcement, the media and the mental health profession. By sharing information and starting a national discussion, these groups can make an immediate impact. Please help us educate everyone and stop the torture!

My name is Olga and I write these statements of and on my own free will and on behalf of myself. I, the affiant, state that I'm a registered nurse and became a victim on or about November, 2013 right after I was fired from the institution where I worked.

I state that I have been tortured by direct energy weaponized technologies, gang stalked, sexually assaulted and sodomized numerous times in my residence, and in my daughter's house.

These energy weapons tortured my body from top to bottom with high levels of heat and cold energy waves, electric shocks throughout my body, phantom touch, hot and cold feelings and a loud popping inside my skull, specifically in my left parietal area, and my frontal lobe of my brain. They torture me by attacking my private organs and throughout my body. The microwaves are directed towards my head, causing me severe headaches, confusion, seizures, faintness, severe anxiety, anger, feeling of impending doom, high pitched sound in my ears, sleep deprivation, my eyes to be red, dry, and the sclera, very yellow. I have severe hair loss, and damage due to these attacks. They attack my throat, making me choke, vomit, cough, and somehow I also experience increase of the production of clear phlegm.

They attack my mid-sternum which is close to my heart, they make my heart rate increase tremendously, also with impending doom feelings. They attack my liver, spleen, stomach, my bladder causing severe pain and cramps. They control my gastro-intestinal tract, my urinary system by holding my normal bodily functions. They attack my musculo-skeletal system with severe electrical shocks, they attack my dermal tissue by electrical shocks, extreme heat, extreme cold, pinching, and induction of severe pain in my arms, legs, face, and throughout my body. I have constant severe musculo-skeletal pain; my skin has become a pasty color, and with severe deposits of lymphatic fluid under my epidermis; I am severely swollen in my lower extremities. On several occasions a laser beam was sent towards my chest, close to my heart. My dog was poisoned; several items in my house were stolen.

I, the affiant, have made several police reports to the Surprise, AZ. police department and received no support. Instead, on two occasions I was threatened with being taken to a mental institution.

I, the affiant was arrested forcibly on November 2014, and placed in a mental hospital for a period of one month, and without a hearing I was placed on court-ordered treatment for one year and forced to take medication for a mental illness I do not have.

I the affiant state that my life has been ruined and I am no longer able to obtain employment. My family is being threatened.

I have not filed a TORT 95 claim due to the fact that every time I have gone to seek or consult a lawyer a group of people will influence or get there first, and one of the lawyers told me "Olga your case is too complicated".

I also fear for my family's life and my own. The loss is tremendous due to the fact that I'm unable to find a job. The torture has taken a toll in my physical and mental health with constant anxiety.

I Olga, have not given consent to extract my DNA, my bodily fluids, to use my body for medical, or use of my brain for psychological, behavioral or social research and manipulation of my body systems including: neurologic system, nervous, cardiac, respiratory, endocrine, gastrointestinal, urinary tract, reproductive, musculo-skeletal, and integumentary.

I have not given consent to governmental institutions, medical, psychology departments, neuropsychologist and other entities. I will never give consent for such atrocities and threats to my health and well-being, defamation of character to isolate me from my friends and family, a severe surveillance campaign, theft of my family's personal photographs, clothing, art sculptures, destruction of my stereo with an electrical beam, constant vandalism to my home, implantation of scorpions, maggots, mosquitoes, flies inside my house and the death of animals in my backyard.

I am or have become a victim of torture, attacks, assaults, harassment, sexual abuse, police abuse, government- funded technology abuse, etc., and am now aware that these technologies are being funded by the United States government with most of these technologies being developed for war and are now also being tested and evaluated per Department of Defense Directive 5240.1-r – Procedure 13 – Human Experimentation (on U.S. Persons and others) for Intelligence Purposes.

As a human being and with human rights I have not given approval for the use or abuse of my body in any form to anyone or to any entity within or outside of the United States government to include any corporation, researcher, scientist, military agency or anyone affiliated within or outside of any agency, corporation or individual that has resulted in the harms that my body, life, property, career and or finances have endured.

I further state that military training documents such as the Department of Defense Joint Targeting Publication https://www.aclu.org/files/dronefoia/dod/drone_dod_jp3_60.pdf; DOD Joint Targeting of Individual and Groups that involves the United States 'Joint Chiefs of Command' indicate the United States Health and Human Services (HHS) involvement, an agency that oversees medical records and show that every citizen is being used illegally for testing and evaluation of war technologies.

I the affiant of this affidavit do object to such treatment and abuse of my body and life. In addition to the above noted military training documents that are resulting in the harm to myself and to millions of citizens of this country I do as well object to the Department of

Defense Directive 5240.1-r – Procedure 13 that has resulted in the destruction of my health as will where this document has existed for decades with no oversight yet it still exists as a published and available document resulting in harm to myself and millions of citizens. The chapter 13 reads as follows:

- C13.1. APPLICABILITY This procedure applies to experimentation on human subjects if such experimentation is conducted by or on behalf of a DoD intelligence component. This procedure does not apply to experimentation on animal subjects.
- C13.2. EXPLANATION OF UNDEFINED TERMS C13.2.1. Experimentation in this context means any research or testing activity involving human subjects that may expose such subjects to the possibility of permanent or temporary injury (including physical or psychological damage and damage to the reputation of such persons) beyond the risks of injury to which such subjects are ordinarily exposed in their daily lives.
- C13.2.2. Experimentation is conducted on behalf of a DoD intelligence component if it is conducted under contract to that component or to another DoD Component for the benefit of the intelligence component or at the request of such a component regardless of the existence of a contractual relationship.
- C13.2.3. Human subjects in this context includes any person whether or not such person is a United States person. C13.3. PROCEDURES C13.3.1. Experimentation on human subjects conducted by or on behalf of a DoD intelligence component may be undertaken only with the informed consent of the subject, in accordance with guidelines issued by the Department of Health and Human Services, setting out conditions that safeguard the welfare of such subjects. I've been a TI since 1972, experiencing both group stalking and electronic harassment. It has been 24/7 for several years, then lesser but still daily, and even seeming to mostly disappear for a while. It fluctuates.

It was made plain to me that it wasn't that my neighbors wanted to rent my apartment to someone else, or because I was doing non-union work, but I was targeted because of obscene telephone calls I made.

After a few years, it seemed that the size of this harassment program and its cost were beyond any company. I hope the following will be of some help, but I admit it may be a bit of a stretch to include these. Since I have only had hints as to exactly what the perps tell people, maybe the FBI could go to them and ask them.

Possible federal code violations:

USC 1001 False statements

I'm pretty sure that the perps are using tapes of me, but are twisting things to present a worse appearance. The people enlisted for the group stalking (neighbors, co-workers, store clerks, etc.), to the extent that I can still locate them, might be questioned by the FBI.

USC 2261A Stalking

If (1)" ...present within...territorial jurisdiction " applies, then they constantly have caused substantial distress. That's their job.

(2) the telephone was used in 2 different ways: many wrong numbers, similar in a way that made it obvious that they weren't normal wrong number calls, and , the other way also was not random happenings. I sell on Amazon.com, and, as I've always feared, the perps got involved. One way cuts my sales, and the other two use devices that are used on me outside of Amazon, in my life. Also, for a period of time, when I would make a call such as with a catalog order, the person would after a while put me on hold, then when they came back, they would do something perp-like (I forget the details here).

USC 2340 Torture

(1) In 32 years of working nights outdoors, five or six things were done by police officers - each in a different city. I felt that they were just borrowed by the perps for a one-time event. But police departments, no. For the past 6 months or so, the San Jose police have become involved, in about 4 different ways, while the group stalking is slowly ramping up.

(2) (B) I felt that the group stalking was trying to alter my behavior, maybe just stay at home alone, but I wouldn't let it.

That;s it for all of the possible code violations. At any rate, I would be open to discuss this candidly and frankly with the FBI or anyone.

My name is Rosanne. I am a 62 year old female and I do not have a criminal record.

In the spring of 2010, after reporting noise harassment (including gun shots near my home) and a suspected methamphetamine dealer, I became the victim of covert harassment.

This harassment included electronic and on-foot surveillance, computer sabotage, relationship sabotage, slander, home and vehicle vandalism, theft, verbal and written harassment, pet abuse, chemical assault, and income sabotage. Also at this time, I became ill with symptoms consistent with non-lethal weaponry use and I was forced onto disability.

I have many signed letters from witnesses, police reports, medical records, financial statements, business statements, and emails from friends who were also affected. I cannot prove the weaponry use so this is, at this time, a suspicion.

I am a Targeted Individual (TI) who has been certified by the State of California to be a victim of 1.) Domestic Violence 2.) Stalking and 3.) Sexual Assault by criminals employed in government position: FBI, CIA, NSA, DA, DON, DOD. My FBI FOIA appeal has been denied by the DOJ because they do not want to confirm or deny an individual's placement on any Government Watch Lists. I have no criminal record, and yet I am still treated as if I am a criminal under continuous investigation.

In 2001, I was RFID microchipped against my prior knowledge and consent in my Temporomandibular Joints (TMJ's) at the Fletcher Allen Health Care in Burlington, Vermont. I am being continuously exposed to Microwave Radiation (MR) and Silent Sound Spread Spectrum (SSSS) used in subliminal messaging for behavior modification, dream manipulation, and mind control. Government agents have used a handheld radio-frequency mind control machine with a dial and one central antenna to induce a state of hypnosis for interrogative purposes and for mind control and behavior manipulations.

Organized Stalking: Composed of several individuals who follow and track, use electro-magnetic weapons, engaged in character assassination, psychological warfare, thief and vandalism of property and alteration of personal items such as food, liquids and surroundings, etc.

Electronic Harassment: is the use of micro-wave technologies for the purpose of causing harm, pain, illness, behavior modification and engaged in human experiments on unwilling subjects for financial gain.

Mail Fraud: Confiscation of parcels and correspondents and tampering of items that invade and opens an individual to identity thief.

Vehicle Stalking: The use of private, government and corporate vehicles for the purpose of using GPS tracking satellites, which assist in the manipulation of implants that are in the body.

Systematic Food & Liquid Contamination: Consists of large groups of individuals who have been installed inside supermarkets and other type of food businesses as “employee” staff. Dear FBI Investigating Agent:

My name is Jaami and I would like the FBI to investigate a case on my behalf regarding covert harassment, covert surveillance and illegal human experimentation which I have been subjected to for three years since January 2013. I am assaulted with radio frequencies, microwaves, electromagnetic waves and it causes serious disruption to my neurological, biological, and emotional states. In addition, my family and I have been covertly implanted with nano- biotech matter which has redesigned our features, racial phenotype and genetic biometrics.

Evidence such as government IDs, medical diagnostic records, and non- digital photos have been altered to match our new look and to conceal human experimentation and harassment. In addition, various vital receipts and items that speak to my bio-metrics, credentials and lifestyle have been removed from my places of residence or storage units.

As per the cause of my targeting, it is multi-fold however it is generally focused on an MK Ultra program focused on sex slavery, sex trafficking, racial white washing, and geo-media, entertainment and politics regarding Latinos, Indians, Asians, and Caribbeans who have some trade- off with white people to steer me into white neighborhoods for trafficking and away from black neighborhoods and away from creating black music, etc.

To reach those aims, advanced bio- nanotechnologies and harsh invisible frequencies are used to torture me into submission and censorship. On June 13th, 2014 at the Targeted Individual Philadelphia Conference held at Chamounix Mansion, forty targeted individuals were scanned for electrical frequency and radio frequency analysis with three different RF scan meters. During my scan the RF meters indicated that moderate to strong frequencies were emanating from my body and delivered to my body specifically in locations I was experiencing tremendous atrophy. That RF report, the bodily disfigurement and physical pain confirm that I am being tortured.

Beyond that, recent MRI, X-ray, mammogram, and sonogram scans show exotic implants all over my body, especially brain, facial, ear, nose and throat, vaginal areas.

None of these artifacts are noted in my medical reports. I have pointed out implants/artifacts to medical providers but none will acknowledge them but across the board, doctors are writing I am delusional or treating me as such. Some of these providers, lick their lips and touch their genitalia.

Lastly, images of myself on and off line to include government IDs, one mugshot, (false arrest), yearbook photos, even some wedding and baby pictures are altered. I reported it to the police but I was met with active denial and my complaints were not accepted, or lost. In addition, I complained to the FCC and FTC and no action was taken. This all speaks to stakeholders using their position to discredit me and to mislabel me as mentally unsound.

In closing, I will add that my targeting is complicated as it entails more than directional energy assaults, the activation of implants, and photo editing. It involves technologies heavily related to holographic science, invisible cloaking, and cyber or software surgery. For example, I have watched pictures photo-shopped as I hold them in my hand or the removal of objects from my hand. Although I mentioned that ethnic groups are involved in my targeting, I would be remiss if I did not mention the significant involvement of a consortium of Latino merchants, religious, civic, and criminal groups involved for pleasure, pain and torture. However, in the interest of time and in keeping with the guidelines Derrick Robinson President of Pacts, International set forth, I will transition to a brief listing of constitutional amendments and federal codes that have been violated as it relates to my targeting.

Constitutional Amendments 1, 2, 4, 9, 13, & 14; Federal Codes: Title 17 USC 1201, 1203, Title 18: USC 35, 182, 241, 242, 245, 247, 249, 373 1117,1512,1510,1513,1622,2261 A, 2331,2340; Title 39: USC that deal with mail tampering; Title 42: 1985; Title 47 USC codes; that relate to malicious telecommunication interference via cable, fiber optic, microwave and wifi signals; and USC CODES that prohibit the modulating of traffic signals, codes that relate sex trafficking, harassment on buses trains, highways. Codes that prohibit the usage of the biosphere to deliver biological weapons on civilians and Codes that prohibit drones being used to deliver implants via mosquitoes, directed energy and for the collection of illegal surveillance.

As your agency knows, electronic harassment is detrimental, non-consensual human experimentation is illegal and covert harassment and surveillance are criminal. Therefore, please open a case and investigate it.

My name is Jesse. I graduated college in May of 2013 with a degree in civil engineering from Penn State, Harrisburg. In June of 2013, I joined a company called Roy Jorgensen and Associates. They were a company based out of Buckeystown, MD. I was given 2000 dollars for relocation allowance which I used to move into an apartment complex in Frederick, MD. I traveled every day to Alexandria, VA to work on a project that this company had recently acquired. This company had 3 other engineers. The strange thing was/is that the other engineers (one in Texas, one in Florida, and one in Georgia) all had multiple projects and responsibilities. I was an engineer on simply one project (this company has since acquired another project in the mid-atlantic region). I noticed that my job did not involve any engineering whatsoever and I had basically been hired to take over part of a job that another lady did not want to deal with anymore.

It wasn't until August of 2013 that I started to get paranoid that this company was bugging my company phone, company laptop, and hiding microphones or other such listening devices in my apartment. I started noticing my manager and fellow employees talking about things I did in private while I was in my apartment or when I went home to Hazleton, PA to visit my family. At that point in time I had no idea that they were reading my mind. Also, it was around this time that I had begun drinking about 4 out of 7 days of the week. When I was in my apartment I began making derogatory comments about the Vice President of the company (who has since

retired), his daughter, my manager, my manager's wife, and his daughter. I had also started complaining about the way certain things were being run in the company.

On December 1, 2013 I started to hear really loud voices screaming and yelling in my head. Since then, it has been 27 months of non-stop harassment and torture. I know they can see through my eyes, hear what I hear, see images in my mind, can control my emotions, and have the ability to create pain or pressure on any nerve of my body. This leads me to believe that this is NSA technology. For the past 16 months I have had almost a non-stop bombardment of thoughts injected into my head (including the V2K) which had included every kind of sick, perverse, and heinous words and phrases that you can think of. I have been to 5 psych wards, got an MRI of the head, got a CT scan of the head, had a spinal tap, parasite test, EEG, been on multiple anti-psychotic medications and bi-polar medications, and have been to many psychologists, psychiatrist, and therapists. Nothing has helped to bring relief.

My family has also now become part of this psychological operation as they are constantly reminding me that they are watching my brother and his wife, and my sister and her boyfriend (who do not live in Hazleton, PA).

Additionally, I have been blacklisted from getting a job in civil engineering, so I have had long term unemployment. The worst part is that they are broadcasting my thoughts to thousands of people (including people in my home town), past acquaintances and friends, relatives, etc. and all of these people believe I deserve it because 1.) I am only 1 guy 2.) The government is behind this so it is legal and 3.) The government is allowing people to realize that mind reading exists and is legal. I am sure there are other reasons why people are willing to listen to me beg for help in my mind on a daily basis, but beyond being purely sadistic I cannot find out a reason. They have started a slander campaign where I have been described as a pedophile, homosexual, heretic, fake, imposter, blasphemer, criminal, drug addict, among other things. They have mentally coerced, interrogated, and blackmailed me in my own mind. They say there are loopholes around the constitution and other international human rights laws which allow them to do whatever they want.

In conclusion, I have no evidence or proof that this is happening to me because it is in my head and happening to my body. It is apparently a huge secret so no one is allowed to let me or my family know. I know this was revenge from that company and they use the things I said in my apartment (which they recorded) as a way to justify torture until they decide to kill me. I am sending this testimony to you in the hopes that it can lead me to be able to have my mind and body back to myself again.

I am a targeted individual and have been attacked since 1994. It began with the sensation that I had parasites crawling on my scalp and burrowing into my flesh. It also began with severe and intense chest pains. I have never had a real heart attack but I assume that the chest pains I felt must be much like a heart attack. The pain would always be present when I woke up and would last several hours. The pain would go away for several hours and then begin again for at least 4 hours. The sensation that parasites were crawling on me and the chest pains lasted for ten years. During this time and till the present day I often will experience hand and leg tremors. The tremors always come at the most inopportune times such as during job interviews or if I am pulled over by police for whatever reason. I also felt little happiness or feeling of joy or contentment which one can describe as chronic depression. This also still happens till this very day. They block, via mind control, most of my emotions, certainly any good emotions and I mostly feel depressed all the time.

I've seen many doctors regarding the tremors, chest pains and the false belief that I had some kind of hybrid immune parasite (some kind of lice or crab). Regarding the chest pains, I went through many tests such as stress echo tests, bone fractures and upper and lower GI, et cetera. The three doctors I consulted with regarding the chest pains all could find nothing wrong with me and all gave up on me. I felt the pain and it was intense which baffled me because the doctors could find nothing. Three doctors, including one dermatologist said they could find no evidence of parasites but they did prescribe topical medication which did nothing to alleviate the sensation of parasites. The dermatologist actually wrote me a letter suggesting that I seek psychiatric consultation since she believed that the parasite thing was a mental issue. I scoffed at the suggestion that it was all in my head but it turns out, it was part of mind control torture. I also saw a doctor regarding the tremors that I was and still do experience. They prescribed many medications all of which had no effect at all. At the time I just thought the medications had no efficacy but I would find out many years later that via mind control they are able to block the effects of all chemicals.

When I was 28 the parasite sensation and chest pains seized. I was introduced to hard drugs at this time through a woman I was dating. When I took opiates and ecstasy for the first time I felt relief and joy for the first time in a decade so as one can imagine I was hooked. I didn't realize it when it was happening but at first they allowed the drugs to do exactly as they were meant to do and in appropriate duration. This was the hook with the worm. Gradually but surely the amount of euphoria and the duration of the experience became smaller and shorter as time went on. This was a trap: because of this I began taking more and spending more on it. One could argue that it was natural and part of tolerance but I am not talking about many years; I

am talking about months. I would have to take 10 ecstasy pills just to get off for eight hours only after 3 months. This is not natural at all. Ecstasy has a half-life of twelve hours. At this time I only took a few opiates, usually 2 to 4.5mg or 7.5mg hydrocodone pills. Since I was 17 I began to have issues falling asleep and staying asleep. I would often wake up once every hour or two for a few minutes and it would usually take 45 minutes to fall asleep. Once I started taking ecstasy the sleep issues became chronic. I thought at the time the drugs were keeping me up all night which of course is logical. Looking back though I would be up for an entire week without a single minute of sleep. This caused great pain. I was a financial database programmer for a large local energy corporation. I would never use drugs while at work at this time but because of the sleep issues I quickly was unable to function at work.

After I was terminated I went to detox and drug rehabilitation and I've lead a sober life for three years. During this time I completed my Associates Degree for Computer Information Systems and I completed a certification as a Network Engineer. I took ecstasy only three times after the three- year sober time and on all three occasions the drug had zero effect. I thought at the time I had bought bunk but I now know they blocked the effects of the drug. I was diagnosed schizo-affective at this time and was accepted for social security disability. Even though I was receiving disability I was anxious to return to work. So I did. I went to work as a network technician at a large local corporation. After about four months of working I began to take hydrocodone pills again. And again the euphoria and emotional gain I experienced from the drug would only last for an hour right off the bat even after being sober after three years. Naturally this made me take more and more of the pills and after a very short while, six months, I was taking fifteen to twenty 10mg hydrocodone pills. After six months of being employed I received my social security disability retro check which was \$45,000 dollars. I, of course began purchasing large quantities of opiates. Eventually I was consuming one 100mcg fentanyl patch along with thirty 10mg hydrocodone pills each and every day. They blocked the effects of the opiates completely at this point which is why I was taking so much. I really, to this day don't understand why I continued to take the drug even though it had no effect. I guess the answer to why I continued to take the drugs is because I would become sick if I didn't use it even though they had no effect which is really a contradiction. I thought at the time, incorrectly, that I was taking so much that I wasn't feeling it. One night, for the first time, I used a needle; I scraped the jell out of a 100mcg fentanyl patch and injected it. That injection, in retrospect, should have killed me as it was an overdose. Their ability to block chemicals completely would cause me great distress in the future when I tried, on several occasions, to commit suicide.

It was at this point, in 2008, that the gang stalking began. It was a gradual progression. My apartment was in a mansion which contained eight apartments. The apartment above me was empty but I would hear loud footsteps from the empty apartment above me, following me

around the house. I would go to the kitchen and footsteps would follow me. I would go to my bedroom and the footsteps would follow me. And I would go to the bathroom and the footsteps would follow me.

When I reported the phenomenon to my landlord he assured me that the apartment above me was empty and secure. I began to smell something was wrong. During this time I would hear my next door neighbors outside my door talking about what I was doing in my apartment and when I opened the door to catch them no one was there. During this time I was also enduring complete sleep deprivation a few nights every month. People at work would say things about me, specifically about my drug problems, behind my back loud enough so I can hear them. Because of my drug problem and because of this harassment at home and at work I decided to quit my job and move to a rooming house.

While I was living at the rooming house the gang stalking increased significantly. I would hear the person in the apartment above me providing commentary on what I was doing. They also started banging on the walls at all hours. One neighbor actually forced himself into my room and physically attacked me. I would try to trick them by going to sleep early and waking up early at like 3am in the morning. As soon as I woke up, the harassment began. I couldn't understand why or how someone would devote their entire night and day to harassing me. The neighbor next to me would also bang on the walls, usually at midnight or 2am when I was sleeping. When I tried to record the banging on the walls and vocal commentary on what I was doing using my iPod, I was unable to record anything even though I could clearly hear the sounds.

It was during this time that strange people would follow me around the city. I would see the same people at so many different locations that it was most definitely harassment. People, complete strangers, would say things about me as I passed by them saying something like "drug addict." A couple of strangers spit on me. During one time I was downtown and about fifteen people were around me. I scratched my nose and all fifteen people at the same time scratched their noses and all looked at me simultaneously. I was in awe and shock at this event.

My grandfather died and at the same time my poor grandmother whom I love very much broke her poor leg (my grandmother is the only person who sticks by me and provides help after all these years, even my mother has basically disowned me or I should say our relationship is estranged). Anyway I moved to my grandmother's house to help her for about six months, moving out of the rooming house. I thought it would be the end of the harassment. The harassment followed me to my grandmother's house. I would see the same vehicles either parked outside or driving by. The vehicles did not belong to the neighbors. When they drove by, and I just happened to be looking out the window, they would often be speaking on a radio. I also heard two men, unknown to me, again, providing negative commentary on what I

was doing in the house. I couldn't understand this because it was a single house many feet away from the only one neighbor's house. I went up in the attic and on to the roof to see if people were up there and found no one. At this time I began to question my sanity. I couldn't understand how I could be gangstalked and insane at the same time.

After living at my grandmother's I moved into another rooming house. The first night I was there, the voices of my neighbors (whom I had met that day and could distinguish their voices) began the commentary on what I was doing and it was accompanied with the sound of a loud clock. Even though the gangstalking continued in a limited capacity, the next six months were some of the better months in my adult life. The opiate pills were working again in a limited capacity and I would feel the effects of it for about two hours and was taking about 15 10mg pills a day. I gained a good friend and I started dating women again. After six months of relative stability I decided to go back to work for a very large cable company as a technical support representative strictly for clients who were companies.

Day three of working I had a date with a new girl that night and went home to sleep anticipating a good day at work the next day. I was deprived of sleep that night. I was taking only methadone at this time, trying to quit the habit without going to a hospital; so nothing heavy which would keep me up all night.

The next day I felt like death. The sleep deprivation affected me much more deeply than should have been natural and again I took the methadone and it didn't work. I came to work five minutes late. Everyone looked at me when I entered (I was in training and the class size was about twenty five people). I sat down and tried to log into the computer but my hands were shaking so bad that I simply could not type. I asked to speak to the instructor and I told him I wasn't feeling well and that I needed to take the day off. The instructor insisted we speak with HR which we did and I gained permission to take the day off. I went home and straight to bed. This was my first experience of being really and blatantly tortured.

As soon as I got in bed the chest pains began again. I was experiencing tremors all over the place. A headache began, and I heard the voices of two men and an ex-girlfriend. They were making fun of me: that they were responsible for the sleep deprivation and that my ex-girlfriend, as she said through the walls, was now sleeping with my friends and they also made fun of my penis size and many, many other items. This lasted for about ten hours. I decided that I couldn't take it anymore and went to purchase hydrocodone pills. When I got back and after taking the pills, the pain, tremors and voices were gone. Around 10pm I fell asleep.

When I returned to work the next day the whole classroom was gang-harassing me. They called me the Peanut Gallery. A lot of them would say "can I take a nap now?" Telling the instructor that I needed to sleep because I wasn't feeling well is one of things I said to him. They also said

things like “I need to take pills now” and one day when I got paid “he just received his ticket to Charlie Wonka's chocolate factory”.

The sleep thing turned into a weapon for everyone to harass me with. At this time I also heard the company manager and the rooming house manager talking through a wall, yet again, about me. They went through my entire history including things that I did when I was a child such as shoplifting. One of the items of harassment was my drug habit and to my great surprise, for the first time of many to come, was accused of being a pedophile.

After two weeks of working at the new company and enduring endless harassment from real people straight to my face, not from voices behind walls, I took a week off to get sober. I obtained a letter from my doctor stating that I had to take a week off for “medical issues.” I got sober. Because the house manager was involved in talking to the company manager I had confronted him. My entire sordid history and accusing me of being a pedophile was obviously untrue. We had a big argument and he of course denied everything. In retrospect, knowing that I am enduring mind control torture I know now that the conversation between managers behind some wall never happened.

Because of the accusations and argument I was kicked out of the rooming house. I moved in with a good lifelong friend. He, as with most people up till this very day began to have serious issues with me. They tweak peoples’ minds around me so they attack me over trivial, petty or untrue issues which is what happened with my good friend. All relationships till this day end in this manner, all except for my Grandmother who seems to be off the menu. I had to move out only four months after moving in. I moved in with my brother who just recently was terminated from his job and divorced from his wife after eighteen years.

Shortly after moving in with my brother I decided to take off from work again to go into a drug rehab because I couldn’t keep clean from the opiates. After I detoxed from the drugs and was admitted to the rehab I went through four days of sleep deprivation. The doctors prescribed Ambien, which is a strong sleep controlled substance and it had no effect on me. Because of the sleep deprivation and the inability of the doctors to help me I left the program early. After I got out of the rehab, and even though it was illegal for them to do so I was terminated from my place of employment. Because I had returned to work for over twelve months I lost my disability benefits. I had to go on unemployment and received only \$250 a week. Not enough to survive and support a drug habit. This is when the very serious torture began.

About two weeks after being terminated, I purchased some amphetamines along with some opiates. There was a strange man with my drug dealer (whom is a female) who I now know was a government agent and I was setup because two or three weeks after purchasing the pills from her that day her daughter returned home from child protective services. For some ridiculous

reason I was a bigger target than a child neglecting drug dealer. That night I didn't sleep at all which was surprising because I took only one 20mg amphetamine and hydrocodone pills. The voices from two men I didn't know coming from downstairs became very aggressive. They began accusing me of being a pedophile that night. They were joined by a female who I was told was the district attorney.

I was told that I was a pedophile and that I downloaded child pornography and then subsequently deleted the evidence. Even so, the so-called district attorney said that I would confess to the crime and then through a plea agreement be sentenced to one year imprisonment. I never downloaded child pornography and I am most certainly not a pedophile. When I asked "who are you guys?" they responded: "the United States Government, yeah baby!" During that night I also began to hear my two young neighbors who were a couple (a young female and young male.) They began chanting for hours "Justin is a pedophile" over and over again. During this time my heart began palpitating extremely. I began feeling a migraine. The tremors began again. My eyes, while shut moved back and forth in my head against my will and a strange vibration, with precision began to attack specific areas of my body including my genitalia and anus.

This vibration is what I came to find out is a directed energy weapon. This torture lasted for three nights and four days. After the second day I was out of drugs and had no money to buy more so to make matters worse I began to experience withdrawal symptoms. On the fourth day, in the morning which I remember very distinctly because it was sunny, raining and very orange. They said "Justin, you are ready to confess to your crimes. You need to go to the window and repeat what I say."

I thought about it. Thoughts flooded my head such as I couldn't win and that there was only one conclusion to this scenario and it ended in me doing exactly what they said and going to prison for something I am not and for something I never did. This was complete thought manipulation. It was at this time that I looked up at the wall and at a painting I own of Vercingetorix surrendering to mighty Julius Caesar and I thought to myself 'what would Caesar do in this event?' The conclusion was that he wouldn't surrender and he would keep fighting. I did the only thing that a person could do after four days of being tortured: I went to the hospital.

At the hospital I explained exactly what I was going through. They put me into the psych evaluation department. It was like a jail. It had only a small waiting room with rubber furniture and two very small rooms with a table and two chairs only in each. There was twenty people there. After that day of continued harassment from the staff, patients, and voices through the walls I finally fell asleep and the pain, heart issue, migraine and vibrations subsided. I was there for three days. I slept on and off on the floor. The doctor finally evaluated me and discharged

me without being committed to the psych ward. At this point I did some research on the Internet and began to realize that I was experiencing mind control and attacks from directed energy weapons to my complete shock and awe.

After being discharged from the hospital for the first time this schedule of torture continued. It would last for four days and I would sleep for about five hours and the torture began again in the aforementioned capacity for a year and a half. I was committed to the psych ward of three different hospitals a total of seven times during the past year and a half. Eventually they induced an excruciating migraine that lasted six months; this, along with all the other tortures. During this time the only thing they stopped was the vibrating directed energy weapon. The pain and suffering I endured during this year and a half torture program cannot be expressed in words. One would have to experience it to understand the sheer pain and suffering I went through.

I believe what ended the first phase of the mind control torture program is that I was forced to say out loud, a script they provided verbally in my head (at this point the voices were internal and external) that "I am a pedophile and that I downloaded and masturbated to child pornography." After I falsely confessed they attacked me very intensely for two days after which I committed myself to a psych ward.

I went to the psych wards because they would often let me sleep, ease up on the pain and it would be quiet in my head. This time I slept for only one hour for four days, then two hours each night for four days and then three hours for four days...I would get an additional hour each four days. The migraine slowly turned into a headache. The doctors provided Tremidol for the head pain which had no effect. After about three and a half weeks I was discharged and I was sleeping about seven hours each night and the head pain was limited.

After I was discharged from the hospital and for the next year the torture was limited to complete deprivation. I could not and still cannot use my imagination. I cannot picture images in my head. I cannot smell anything. This also limits the taste of food and of course all chemical stimulants or drugs of any kind have no effect on me. Even coffee and cigarettes have no effect on me. Anti-psychotics, anti-depressants, anti-anxiety and illicit drugs do not work on me. Alcohol does not work. This deprivation has been going on for four years now and continues till this very day.

During this year the headaches were intermittent and very limited. During this year, minus one night I slept very well for about twelve hours every night. After this year my brother sold his house and I had to move again. I moved into a room in a house with a retired and disabled gentleman, so I walked into the hospital coherently and told the staff and doctors what I had done. What is so unbelievable is that the doctors didn't question how I was still was alive. It

doesn't take much research to come to the conclusion that not only should I have been dead but at the very least in a coma. Why the doctors didn't seriously question how I was walking and talking is beyond me. They knew I took all those drugs because they did a test after I told them what I did which confirmed the drugs and quantities that I had taken of those two potent narcotics. If you ask me this is proof of mind control.

After three months of being homeless. I moved into another rooming house and live there till this present day as I write this document. The date is March 1st 2016. After I moved into the new rooming house I wrote a 200 page book of my experiences which I do plan on publishing eventually . After I wrote the book the torture became serious and intense again I believe as punishment.

Sleep deprivation for three nights and then five hours sleep for one night or up to three, migraines, and severe illness which is just completely debilitating me. They even intensified the attacks on Christmas eve and Christmas day right in front of and while I was with my family. Taxpayers' money and resources going to good use. These attacks have been going on for over five months now. I no longer take any drugs since I only have bad effects from them and as mentioned my senses are totally deprived.

As of today the list of what I go through is: imagination deprivation, smell deprivation, I am very skinny now, emotional deprivation, all my thoughts seemed to be controlled and I am always thinking about the tortures I am experiencing, stimulation deprivation wherein not even coffee works; I am physically ill most of the time. I was so sick one day returning from shopping that I had to lay on the dirty wet and snowy ground. Sometimes I experience migraines but I always have a headache which of course cannot be helped by conventional means such as over the counter medicine; around the clock 24/7 verbal harassment in my mind and even while I dream; they somehow prevent me from taking showers or basic hygienic tasks, I believe through emotional and thought manipulation because I become terrified when I think of doing basic hygienic tasks. The list goes on. They seem to always have some new way of tormenting me daily.

I have tried to commit suicide an additional two times. Once again I tried the BBQ method but this time using a huge charcoal grill and many bags of charcoal. I sat in a carbon monoxide room for three hours and felt not a single side effect. I tried to hang myself. I hung myself using a cut sheet that was attached to a hook screwed into the top of the doorframe of my closet. I went unconscious and was good as dead...finally...relief. The next thing I am aware of after that was getting up off the floor and actually, get this, being afraid that I did not hear the voices for like 30 seconds. The top of my door frame broke off and dropped me to the floor. Since that incident for some reason, through what I believe to be mind- tweaking, I am unable to complete the much desired task of ending my tortured existence.

One would logically assume that what the government is doing to me is experimental in nature and that they are developing weapons. If one thinks about it though experimentation does not make sense because what they have done to me has been done hundreds of times over and over again. They know what they are doing and the effects of it. Take the sleep deprivation for example: they sleep deprived me at least around a thousand times probably and they know what they're doing and the long term effects of it. Also take the sensory and chemical deprivation, they know what they're doing and the long term effects of it. They have been doing it to me for four years now. They are not experimenting nor developing weapons. They couldn't use biological weapons on our enemies anyhow because it's against international law.

I speculate that, from what I ascertained through research this mind control program started in 1980, a few years after MKULTRA was shut down. There is no doubt in my mind that back then it did start as experimentation and weapon development but I now believe that it has become a bloated, useless black operations government program and that the directed energy weapons and mind control have been perfected. And to justify its existence and hence the jobs, the infrastructure, technology, control of people and most importantly the black over bloated budget, they justify it by torturing innocent civilians in the name of experimentation to the powers that be, the President of the United States of America. It's filthy and disgusting.

I did not have the space to cover the full depth and detail of what has and still is happening to me in this small summary. If you are interested, I plan on eventually publishing my book regarding my experiences. The book's title is "The Marionette", so if you're interested, watch out for it in the next year. Sabotaging of my Work and Targeting of My Sponsors

My work has been sabotaged in ways, which include interference with mailings, the destruction of my computers and printers, affecting my health with microwave and laser weapons, infiltrations into my computers to alter or plagiarize my writings, changing my phone numbers, taking over my email address, wiping pages off my web sites, etc. But the worst of it

has been the targeting of my advertisers since the 2008 printing of Sharon's Bud.

In 2014 Daniel N, promised to sponsor my next Heart Bud publication shortly before his "Gold Buyers" shop in Greenland, NH was broken into. This was my last attempt to find sponsors for my publications, because there has been a long chain of what appears to be targeting of my sponsors in the second issue of Sharon's Bud and four issues of the Heart Bud. (Possibly even subscribers of my 2005 "Personal Journal" publications.) Most (if not all) of my advertisers appear to have either gone out of business or been targeted with break-ins, bursting pipes, sudden odd deaths or illnesses of loved ones, etc. So much has happened that I can no longer see it as a coincidence.

Since I learned of Dan's suspicious "death," (which is listed below), I began to realize that things appear to be getting worse instead of better in my situation, especially for past advertisers of my papers, witnesses to the targeting, and possibly even people who I had written about in the original posts on my blog, which are now in the book listed below . . . or should be. There are things that may have been altered or erased by those who infiltrate my computers and web sites. (I've been getting what appears to be covert threats connected to the writings in this book.) I feel bad that I must share it in its raw form, although it has been infiltrated and I had made too many of my own mistakes, misperceptions...etc., and certainly do not want to misinform or let blame aim in the wrong directions. But I cannot properly fix/edit it on infiltrated computers and feel that I need to share it so that the crimes do not remain hidden. More complete earlier editions can be made available to the proper authorities upon request. Hopefully they will remain intact.

Since my work has been so severely sabotaged, I have repeatedly aimed for other jobs. On those jobs, I've experienced what appears to be laser weapon attacks to my back, hands and arms, which were inflicted to disable me until the job was lost or not obtained. On jobs that I have obtained, I've experienced severe levels of harassment (including sexual), rumor campaigns, being drugged and raped, and microwave weapon attacks to make me physically ill or interfere with my brain function.

Suspicious Deaths

Before you read this I want you to know that I do not have an issue with death. I fully believe that our souls/spirits go to a better place after our bodies die and I actually find comfort in

knowing this. But there are some deaths surrounding my situation, which feel too unnatural and appear to be inconspicuous murders that are set up to look like suicides or natural deaths. Some appear to be part of a targeting and abduction/"rescue" process that is orchestrated by those who target and enslave people. Some enslaved victims are thought to be dead by loved ones - their "deaths" staged. I beg you to help stop these crimes and expose the covert program so that enslaved victims can be set free and not used to "recruit" or target the rest of us.

Death of Daniel Nadeau of Greenland, NH in 2015;

Dan had been one of my advertisers in the 2008 second printing of Sharon's Bud. Dan had also helped me when my car was disabled and I was left stranded on the streets in the fall of 2013. On February 28, 2014 I reported that Dan's "Gold Buyers" shop was broken into shortly after he had agreed to sponsor the next printing of my "Heart Bud" publication. . .and that I thought it was part of the targeting.

Around July 28, 2015 it appeared that Dan was being used to try to get me to leap into his car - to "rescue" me from the targeting. "He won't go without you," one of them said as this was happening. On one occasion Dan parked next to me, walked in front of my parked car and then appeared to be sitting in his car waiting for me to leap into the back seat. Those who target me have recruited and/or abducted and used, many people who I knew or had been close to, and used them to try to covertly "rescue"/abduct me. Due to my experiences with this, I feel that this "rescue" (into a place they call "home") leads to complete enslavement under the very same people who are targeting all of us.

On September 6, 2015 I heard that Dan was reported to have died of a heart attack on February 22, 2015, months BEFORE I saw him. Is he really dead? Cover-ups are happening around this. The dates appear to have been altered in my reports of this. And my February 28, 2014 blog post had been partially erased after his death.

Dan is one of several people, who I now feel are probably still alive and enslaved although thought to be dead by loved ones and the rest of the world. It appears that staged deaths, which hide abductions, are merely one of the recruiting methods for those who target and enslave people.

Four Deaths in Northfield, Vermont in 2012;

I visited a church in Northfield and befriended the minister and a few other members of the congregation as I sold books and looked for a room rental in this area where I had just obtained a job. (none of these books were about the targeting.) Within just a few weeks that community, which had embraced me with kind, open arms, was stricken with four sudden deaths. One was the elderly man who I had breakfast with during my first visit. He was missing on the day I returned and was later found dead in his field. The cause was reported to be a heart attack. This was followed by three other deaths, which had the whole community spinning in every direction but mine. This was one of the more extreme situations where people seemed to be targeted, and distracted by deaths of loved ones, due to their care for me. This sort of thing has happened often, probably more than I realize or even want to know right now.

Death of the two aunts who would have helped me;

In the summer of 2008 I sent a letter to my aunt Alene, who was a Nun in Montreal Canada. (I

was wanting to go see her about the targeting.) After a period of no response, I found out, through the internet, that she had died of a sudden illness. This same thing also happened in 2006, when I was about to go see my aunt Francis in Florida. Her first husband (my uncle) worked for the FBI and there may be a connection between his job and our family being targeted.

The Psychological Death of a Child in late 1990s and the following decade:

I worked at a mental health facility for a few years and worked with a two year old boy. He was having adverse reactions to psychiatric drugs. I reported this to the lead psychiatrist who kept trying different ones. I opposed it, because he was normal - nothing wrong with him. But his psychiatrist said that keeping him medicated and quiet was helping his mother to treat him better. I was taken off the case and, around a decade later, I was told that that little boy had become retarded and was institutionalized. I am deeply concerned that these sorts of things are happening to many people.

Kevin's Death on River Road in Goffstown or New Boston, NH in 2002:

On Dec 2001 my brother Kevin called me and said, "Something weird is going on around here! Pops is suddenly acting strange..." ("Pops" is what he called our father.) I did not know what to think of it and was being so heavily targeted that I forgot it. But it is now clear to me that he was starting to realize the technological mind control part of the targeting, which none of us were aware of at that time.

In August 2002 Kevin was reported to have been killed in a mysterious accident with a four wheeler and was found face down in a river in New Boston, or Goffstown, NH. Many people knew that there was something suspicious about his "accident" but, as they pushed for investigations, my cousin suddenly died of a heart attack. I believe that the second death was a murder set up as a distraction, because this is a typical pattern of the targeting. I now have reason to believe that Kevin is still alive - that his death was also staged and that he is enslaved in the covert program. (His body was not cremated and is supposedly buried in the family graveyard in New Boston, NH.)

Within two days BEFORE my brother's "death", a perpetrator puppet had talked about being scared of his little brother dying. And this is a classic type of sadistic forewarning that those who target me put out before executing their plans.

Death of Jim in Nova Scotia, Canada in 2001:

Around a serious vamp up in the targeting, and shortly before a suspicious fire destroyed my Andover (Potter Place) NH home, a friend of mine, who was selling me a piece of land in Nova Scotia, was reported to have been found dead in his house near Berwick, Nova Scotia. This was reported to be from a heart attack. But I have reason to believe that he is still alive - that he is yet another person who has been abducted/enslaved.

My oldest daughter was surrounded by an unusual amount of deaths;

Around the late 1990s to 2001...etc., my daughter's friend's grandmother, who she'd been

close to, passed away and she had a hard time dealing with it. . .and then she was suddenly surrounded by unusual deaths. (This is a pattern in the targeting - instigating things that we have issues with.)

Another friend's mother was suddenly found dead with both of her grandchildren, in Penacook, NH. It was reported that she had killed her grandchildren and then herself. (I do not believe that this woman did such a thing on her own accord.) One of her other close friends got married and then her husband shot himself in front of her. They called it suicide. (around this time we also lost three pets.) A few years later she walked into her co-worker's apartment and found him dead. Reports said it was from diabetes. (Both of my daughters have been targeted/traumatized in various ways.)

Death of Charlie of Mont Vernon, NH in late 1980s or early 1990s;

I have reason to believe that my father in law, Charlie was targeted into inhumane suffering while being murdered with microwave weapons. He truly is in a better place now, but how many other people are being harmed the way he was?

Death of my mother, Yolande, in 1977;

I now have reason to believe that my mother never died - that her death was also staged and that she was forced into covert enslavement under the guise of a covert "rescue" from a hospital in New Hampshire.

Examples of Attempts to Harm Me

These are just a few of the more obvious things. I may never be able to prove them, due to efforts to hide the crimes, especially in the past three years, but they did indeed happen. Since the end of 2005 I have been literally fearing for my life, and that of estranged loved ones...etc. Please help us.

Metal Object Shot at my Car in Kittery, Maine in Summer of 2015;

This hit my windshield just a short distance from my open window and head and was done after a threat was delivered.

Shot With a Laser Weapon in Portsmouth, NH on June of 2013;

This gave me severe heart attack symptoms with a laser type of weapon that delivered an intense vibration aimed at my chest. When I moved I felt the vibration in my neck and head. My heart reacted violently. I experienced severe pain in my chest and could hardly breathe for a while. It took a few days to completely recover.

Inflicted With Anthrax in York Beach, Maine in 2009 or 2010;

In November 2009, I rented a room in a rooming house in York Beach, Maine. Between the time of my looking at it and deciding to rent it, the manager told me that a couple of Navy boys had just called to rent two rooms after I left.

On the evening of December 23rd my lungs had a strange reaction to something directly after

I climbed into bed. On December 24, 2009 I worked through the day while enduring the worse type pain I'd ever felt in my lungs. Later that night I was sitting in the kitchen when one of the Navy boys came in, took a phone call and then rushed out the back door. I suddenly felt like something was wrong. I rushed to throw my belongings into my car, but was hit again, while in that process. I went to the hospital but they seemed to think I was just crazy, because I said I was being targeted.

Through the next few days I remained in a lot of pain, had a hard time breathing and continued coughing up globs of mucus that had little black dots in it. Someone told me that it sounded like symptoms of anthrax. But as I went to another clinic to be tested they referred me to a government agency who told me that there had just been an anthrax exposure reported and they were suddenly flooded with phone calls, from people who feared possible anthrax exposure, and mine got lost in that shuffle. This sudden anthrax scare, right at the time when I was trying to be tested for it, feels like too much of a coincidence and is typical of the distractions set up to cover the targeting.

As I recall this chain of events, now that I am a lot more aware of the tactics of those who target me, my mind is filling with questions; Why would the Navy send people after me, and if they did, would they foolishly make it so obvious? Were those guys REALLY from the Navy or did someone just want me to think they were? I am recently realizing that the more lethal parts of the targeting are often surrounded by manipulations designed to make us blame the wrong people. I now feel that this was probably one of them.

Loss of Brakes Near Needles California in January 2009;

On highway 40 I suddenly experienced the loss of my brakes and what appeared to be the microwaving of my vehicle. The whole electrical system went down and stopped the vehicle, which started rolling backwards toward a cliff. I shoved a block of wood under the wheel and called 911 for help that never arrived. This was after I had tried to report being drugged and raped at a driving job and had sent a sample of drugged water to the LA FBI. . .and after visiting a woman whom I now realize was connected to a group who was part of the targeting. I had the truck towed and a garage attendant told me that BOTH rear brakes had been "over adjusted" causing them to fall apart and malfunction. Oddly, he had me go in after hours, in order to help me through telling me that someone was trying to harm me. He said that if he had told me as an employee of this garage he'd have been fired. I found this odd. But I am now concerned that worse may have happened to him since I have realized that I am held under surveillance by those who target me. They probably know that he helped me and was an important witness.

Attempted Murder on Saint Lawrence River in Alexandria Bay, NY in 2006;

In 2006, I was aiming to photograph lighthouses for a series of gift cards and Poetography prints, which I was creating for my work. I'd shared this with people and was asking about how to get to a light house, when a man told me that some could only be viewed from the river. He offered to take me out on his boat to a few lighthouses on the Saint Lawrence river in Alexandria Bay, New York, which is where I was at that time. I took him up on the offer and got two great pictures. But something odd happened out in the middle of the river. He turned to me and asked if I could hand him his jacket (or something) at the back of the boat. I stood up

and went to the back of the small boat and then he suddenly full throttled it. . .nearly knocking me overboard. Thank God I was able to grab something, which prevented it. He behaved strangely (very quiet and hardly looked at me) after that. Oddly, at the time, I did not even think that he had done this intentionally. I'd thought he had probably slipped and fell into the throttle. . .or something like that. But I now feel that it was an intentional attempt to harm me - possibly even kill me.

This happened within a month after I had told someone that I was drugged and raped by a couple members of the occult I was being targeted by. It happened as I was fully facing what had happened to me and as I was aiming in the direction of reporting it.

Diagnosed with Lupus in 2006 in New York;

After I reported the rape and after the attempt to make me fall off a boat, I suddenly got really sick and went to the emergency room. A doctor took blood tests and said that my SED rate was dangerously high - that I was near death. Another doctor ruled out other possible causes with new tests and said that I had lupus. (I now feel sure that this was microwave induced.) Shortly before January 18, 2006 I publicly declared that the lupus, which I'd just been told I had, was caused by harmful energy that was being directed at me from the dark occult. This conclusion was partly due to sets of dreams I'd had, which appeared to be warning me that I was sick due to harmful energy being directed at me. (At that time I was not aware of the microwave weapons, which I now feel it was being done with.) After publicly sharing this I was attacked so severely that it nearly put me back in the hospital. Around this time my business email address had been taken over and I was being heavily lasered while driving, so badly that they appeared to be trying to make me get into an accident, especially as I aimed to leave the area - Clayton, NY.

Parachuting Accident in 1999 or 2000;

I went parachuting with someone. The instructor, who I was lined up to jump with, suddenly decided to take someone else before me, because that person was in a rush. Then the instructor told me that, on that jump, which I was lined up for, his parachute failed and he ended up having to cut it off and open an emergency back-up shoot. He was so shaken, he said, that he was not doing another jump that day. I never got my turn, which is probably a good thing for both of us.

Attempted Murder in Peru in 1999;

While hiking the Inca trail the leader of my group was overly persistent with wanting to help me over dangerous parts of the trail. Aside from him I was the most experienced hiker in the group. I kept refusing his help, but he persisted. During the one time when I relented and took his hand, to round a dangerous drop off, on the tall mountain that juts up above Machu Pichu, he suddenly let go of my hand - pushing it outward as he appeared to have tripped. Luckily I'd still had my left hand on a rope and had not been fully relying on him. The drop would have surely killed me. I now feel that his "tripping" at that moment was not accidental. This trip was

suggested by a friend of his - the woman who I had just told about the dreams I had about something bad being put into public water supplies and about her taking bad water to children at a school.

That first trip was so bad that I vowed to return to Peru by myself. This second trip was in September 2001. And to make a long story short, it was filled with so many odd occurrences that they canNOT be viewed as coincidence. On the day I was to return to Cusco from Machu Pichu, the train suddenly broke down and I was flown out in the cargo part of an old helicopter, where the stench of gas was almost too much to bear and left me feeling sick. As I aimed to fly from Cusco to Lima, on my way back to America, the flight was suddenly canceled or late and I was rerouted onto another flight, which I was told was the last one to leave due to it reaching a time of day when it was too dangerous to fly over the mountain range that I was rerouted over, in order to catch another flight that would then take me to Lima. The flight was terrifying for all passengers. The plane kept dropping out of the air. We thought we were going to crash on a number of occasions. People were screaming and vomiting. It was horrible. Oddly, the attendant, instead of apologizing to the passengers, had smiled and said, "I hope you enjoyed your flight" and some passengers became enraged and yelled at her.

Dumped beneath dangerous rapids in an ice cold river in Andover, NH in late 1990s:

A man had tried to harm me while we were whitewater rafting. The raft was stuck at the base of a waterfall and he stepped onto a rock, climbed out and tipped it over, dumping me under a powerful water fall that held me under the water. Then he kept pulling the raft away from me as I surfaced choking and groping for it. I nearly drowned - I inhaled a lot of water. We were rescued from an island by one of my neighbors, because I refused to get back in the raft with him. On another occasion he had thrown a 4x6 timber at me, through a window in my home. On another occasion he'd tried to inconspicuously shove my hand into a running saw blade by pushing on a board I was about to cut, while pretending that he we was just trying help me by adjusting it. This man was an obvious operative for those who target me. I was in a relationship with him for about 3 years, during which time I now feel that he was drugging me and harming my daughters as well. (He was also the one who later told me that he was concerned about his little brother dying just before my little brother died.)

Unexplainable Loss of Head Lights on my car in NH in the late 1980s and early 1990s:

The head lights on my car would suddenly stop working while I was driving in the dark. Mechanics couldn't find anything wrong with it. This never happened when my husband drove it, but it kept happening to me. I now feel that this was being done remotely and to stop me from visiting my stepfather, who I now feel certain was being murdered with microwaves. Oddly, I cannot remember the year but it was in the late 1980s to early 1990s.

The Mill Fire in New Boston, NH in 1980:

In the spring of 1980 I was between 7 and 9 months pregnant, and at my father's home babysitting my twin niece and nephew, when a fire suddenly broke out in my father's shop. I saw the smoke through the kitchen window and rushed upstairs to get my little brother. (We were the only ones there - my father had gone shopping.) While my brother raced outside I picked up the phone, but it was dead. (There was no reason for the phone to have not been

working - the fire was not near the house or power lines.) I was unable to call for help so I rushed outside, where my brother was trying to access the building and move my father's trucks. I yelled for him to take my car to a neighbor's house and call the fire department, because I was caring for my little niece and nephew.

He raced off in my cougar and a few minutes later, our closest neighbor drove into the yard with two other men crammed into the cab of his truck. "You'd better move that gas tank or the house will blow up with it," he called out as he turned around and all three of them drove away, leaving me there, obviously pregnant and with two scared and restless 4 year old children. Fear gripped me at this point. The flames were circling around a diesel fuel tank and getting closer to the larger gas tank he'd referred to. I rushed the children to the other side of the house, in case it exploded. And every minute felt like an hour while I waited for help to arrive. There was no way that I could move the gas tank by myself even if I did not have to take care of the children.

Meanwhile, a tire fell off of my car while my brother was racing for help. (The lug nuts had been unscrewed.) But someone happened by and the fire department was eventually called and arrived after the building was mostly burned down. This was an old farm building that was about 200 feet long and 50 feet wide.

The cause of the fire was never determined. Nobody, that we knew of, had been in the building for about an hour, and so it was assumed that it may have been caused by a smoldering spark from a grinder that my older brother had been using before he left.

Rumors spread that my father torched it for insurance money, which added to the distress. He'd have never done such a thing. It was not even insured. I have recently realized that the false rumor is a typical pattern of the type of targeting I've been experiencing - the exact same rumor was spread when my home was destroyed in a suspicious fire almost two decades later.

Now that I know we are being targeted, its like another puzzle piece clicking into place - it appears that the fire was set and that the phone and vehicle were disabled, in order to prevent help from arriving. (This property was a large farm and was 4 miles from the center of a small town.)

Motorcycle Accident in Goffstown, NH in 1977

In the 1977 summer, while my mother was in the hospital, an elderly man pulled out in front of me. My bike, struck his car sending me flying over it and landing hard on the pavement where I remained, in horrible pain, until an ambulance came. The arrival of the ambulance ended up being an extended period of time, because, one of the EMTs suddenly started having heart attack symptoms and the driver was forced to turn around and bring him to the hospital, instead of picking me up. (This was on the front page of that week's local newspaper with a picture of me being hauled off on a stretcher.) Meanwhile it had started to rain and a couple of police officers were holding a tarp over me until a second ambulance could get to me.

Another unusual thing about this accident is the way someone, who had witnessed the accident, had run out yelling and screaming at the elderly man who'd pulled out in front of me. "Look what you have done! You've killed her!" he screamed. Now, in looking back at it, it seems like this was staged.

I was run off the road on route 101 in New Hampshire in 1975 or 1976;

I ended up in a serious car crash that destroyed my car, broke my collar bone and gave me a concussion. There was a witness to this. I must have gone unconscious for a little while and, when I came to, a police officer was standing at the door of my car and a woman was crying out, "they just ran her right off the road!"

I was taken to the hospital and tortured by a doctor who had two orderlies pin me down, without ever explaining what they were doing, while the doctor shoved my collar bone back into place. (This same doctor also tortured my little brother through stitching his head with no novocaine...etc.)

My mother must have sensed something wrong, because she came to the hospital and took me home, against doctors orders, while I was so drugged that the details are a bit foggy. Shortly after this, my mother was diagnosed with leukemia and we lost her just before Christmas in 1977.

Sudden loss of brakes in Goffstown, NH, In 1976;

I approached a stop sign, went to hit the brakes and the pedal went to the floor - I had no brakes! I flew right through the stop sign at the corner of route 13 and Bog Road and almost hit a truck, and then plowed into a snow bank in order to stop the car.

Exactly why the brake fluid had suddenly drained out of my car was a mystery and the mechanic/friend who had worked on the car, prior to the brake loss, assumed that maybe he had absent mindedly left a wrench on the bleeder and it had loosened the bolt as the car bounced over bumpy roads. None of us had even considered the possibility that someone may have intentionally drained the brake fluid out of my car, because I had no idea that I was being targeted or that anyone would want to harm me.

But I now believe that this is most likely what had happened. I have learned that the targeting is often set up to place blame on someone else. Tampering with my brakes after a mechanic had just worked on them would be the type of timing they'd leap to take advantage of.

The Targeting of My Homes

The most obvious targeting events have included the taking or destruction of my homes. I may not be able to prove most of the details, especially if things are covered up and witnesses are targeted into silence one way or the other. And unfortunately it looks like this has already been happening to some degree. But my statements below are true.

The NH Department of Transportation Taking of my Loudon, NH home in 1995;

There appeared to be repeated attempts for perpetrators to take over my country home, on the corner of route 106 and Staniels Road in Loudon, NH, after my husband and I divorced. Two people offered to buy it and let me continue living there. Two had tried to actually move in with me. All of it was done under the guise of help and by those who I am now realizing were part of a perpetration infiltration into my life in the early 1990s. I had refused all of their offers. And then the DOT took my home under their rights of eminent domain.

The process of the DOT taking my home was dragged out, leaving me in an uncomfortable

position, financially, because their plans to put a road through my property were preventing me from selling a commercial part of it and from freely continuing my in-home business.

At one point I had called a newspaper reporter with the hope that some exposure would help swing things into a more positive direction. But the reporter stopped by the DOT office before coming to my house and the DOT called me while he was driving from there to meet me, and informed me that everything was looking better and set the date for the closing. I didn't realize that this was a manipulation at the time. I had believed that things were genuinely swinging onto a better course and that there was no point in pointing out the negative details to the reporter. When the reporter got to my house, I told him that the DOT had just called and that everything had changed. "I'll bet they did," he said. The phone call from the DOT and my lack of awareness set the course for a newspaper article in the Manchester Union Leader, which made it all appear like it was a good thing. But it wasn't and things got worse and it seemed like there was nothing I could do to stop any of it. Local lawyers even refused to help me.

The closure date was delayed after I'd shut down my business in preparation for the move. This left me with almost no income. An official at the DOT suggested that I go on welfare. I was mortified. (The aim to sabotage my homes and work and try to push me into welfare or disability is a strong pattern in the targeting.)

I remember getting a call from a DOT official after the newspaper article came out. He told me that it would be best if I did not talk to any more reporters. And then he said that he was friends with the president of the bank who held my mortgage and was having dinner with him. After this he said something like, "Do you know what I mean?" But I didn't know what he meant, at the time. I thought it meant that he was going to put in a good word for me. I followed through with my plan to visit the president of my bank, explained the situation to him and asked if I could make lower payments - just the principle part of the mortgage, until the state followed through with the purchase and it could all be paid off. Within a couple days, a really mean-sounding thug called and said that my home would be immediately foreclosed on if I were to be late on just one payment. This was shocking, because I had NEVER been late on a payment and had perfect credit. I had gone to talk to them, with the hope of preventing such problems.

A friend's father had stepped in to help me. I think he had called the DOT and then he came to the closing, which is probably what made things go better than they had been. (But that friend's family appears to have been targeted as well.)

During the taking of my home I rented a room to a woman whom I now believe may have been drugging me. My reactions to the DOT became extremely uncharacteristic of me. At one point I wrote F----- You in a letter to them. This word was not even in my vocabulary! And I had changed my name from Sharon to Namatari in the middle of the process, which is also odd.

The Fire in My Andover (Potter Place), New Hampshire Home in 2001:

I am in the process of remembering more of the details, which surrounded the suspicious fire, which destroyed my Andover (Potter Place) New Hampshire home in 2001. Like other heavy parts of the targeting, it was surrounded by extenuating circumstances and odd chains of deaths and events, but this is just about the fire. Around the evening of May 7, 2001 I arrived home from shopping and my house was on fire. I called the fire department. But there were a

few odd things that surrounded the fire and the process of putting it out.

1. I heard that there were two other fires on the same night. And I think that the first responding fire department, which took charge at my house, was not the local one. As things seemed to drag on with what appeared to be no attempt to put out the fire, a local fireman, who was off duty, tried to find out what was happening. I remember him apologizing to me and frustratedly saying, "I'm not in charge here." Apparently they sent him away.

It was hours before a pool of water was set up in the yard to extinguish the flames. The odd thing about this was that I had a large brook in my back yard, which the local fire department had used for a practice drill, to help me fill my swimming pool with water, just a few years before this. The water was already there and this was well known by the local fire department.

2. After the fire was finally out, and the fire trucks were pulling out, a police officer came to me and asked if I wanted him to call the fire marshal and have an investigation started. As I thought about it he said, "I would if I were you." And I agreed.

3. The fire marshal, and a few other people investigated for a few days. The marshal told me that the burn pattern was suspicious - that due to his findings, and a police report, it looked like the fire was put out in one room and then restarted in another room.

The fire marshal was trying to figure out how the fire jumped from one room to the other without the normal burn pattern. He'd repeatedly asked me what was in the room, where the fire appeared to have been restarted, but my mind kept going completely blank; for some odd reason, I could not remember what was in that room while they were there and questioning me. It ended up being listed as an unknown cause.

I later remembered what was in the room, because it was the room, which contained my most cherished personal belongings, and I soon started missing them. It contained my journals, where I had logged nearly three decades of experiences and dreams; notebooks filled with over three decades of my poetry; the final manuscript to a book, which I'd just written on the subject of "Embracing Feelings" and avoiding psychiatric pharmaceuticals; thousands of dollars in cash; my address book - all of my personal contacts; my clothes...etc. (Please read this article; www.targetedinamerica.com/psychiatry.html)

4. Shortly after this fire, another fire broke out in the storage bins where I had stored what was left of my belongings. I have reason to believe that this was NOT a coincidence. (oddly, an operator recently told me that the address of this property does not exist!)

The Alstead, NH Flood and the Rape in 2005;

Near the end of 2005 a flash flood wiped out my Alstead, NH neighborhood. This was reported to have been caused by a stalled storm and a plugged culvert. I now believe that the storm was probably stalled by weather modification technologies and that the culvert may have been intentionally plugged.

After the flood, a couple zoomed in to "help" me, because I no longer had a home to go to. When I got to their home my vehicle was boxed in so that I could not leave without them

moving their own vehicles. (There was plenty of room for this to not have to be this way) While I was there I was drugged and raped and lost over a week of time. During my week or two that I was held there I was also brainwashed into thinking that I was responsible for the deaths of the four of my neighbors who died in the flood.

When I later reported the rape to their local police chief, nothing was done about it and the tire on my car suddenly went flat while I was in the police station talking to the chief. He seemed involved and other weird things happened, which I may share later.)

Vandalizing of my RV in Mohave Valley, Arizona in 2011 and 2014;

By this time I had been targeted so much that a beat up RV was all I had left for a home. In 2009 it had been sabotaged, even the fixing of it was sabotaged, and I ended up putting it in a storage yard. In the fall of 2011 I had just gotten a job, and had expressed to someone that I was going to fix my RV as soon as I got enough money saved. Within a couple weeks, I got a call from a police officer, who informed me that my RV had just been vandalized. It was vandalized again in 2014.

Sabotaging of my Vehicles

I have experienced what appears to be remote attacks to my vehicles, which have drained or destroyed batteries and stopped the engine from working, either breaking something or just leaving it unstartable at strategic times. (This was happening severely in 2008, 2009, 2011, 2012, 2013, 2014 and for a period of time in 2015.) My driver side windshield wipers have been repeatedly damaged at eye level. Something has often been sprayed on my windshield that makes it almost impossible to see out of when it gets wet. Some sort of chemical that causes erosion appears to be put on at least two of my vehicles; once on my brake line which broke while I was driving in 2012. My radios have often been broken or interfered with. Something like salt has been put in my driver side doors through the window opening. I have experienced things being shot into my tires, a screw, metal object and a bullet. I have experienced the sudden unexplainable disintegration of part of the fuel injection system, causing gas to literally pour out into the air filter and onto the ground. I have experienced episodes of unexplainable electrical problems in vehicles. I have experienced repeated episodes of my oil filter being unscrewed and bolts removed from the transmission once. I have experienced an unusual amount of belt breakage and brake losses in vehicles. I have experienced things being moved around inside my vehicle; a knife was once placed in it, etc. I now get ongoing threats to disable my vehicle, which is now my home and contains all I have left of my writings. (This is happening again as I write this.)

Laser, Microwave and Psychotronic Weapon Attacks

I have experienced ongoing weapon attacks of various types. Most of it appears to be to interfere with my brain function. Some of it is to inflict physical pain and threaten me with heart attack symptoms and attacks to my lungs and throat. I have had burn marks on my body and

have experienced ongoing attacks to my pubic area, severely since the fall of 2013. I have experienced literal brainwashings and attacks to my brain that appear to instigate abnormal feelings of anxiety or anger at strategic times. I almost always hear the ring of microwave weapons in my ears and, aside from the obviously painful attacks, I am periodically inflicted with microwaving that causes things like extreme fatigue, intense heat or sudden bloating of my whole body. The technological targeting sometimes suddenly backs off at times and I have been deeply concerned that this may be done to prevent detection - that those who target me seem to know if possible help is zooming in. It also appears that the opposite happens - it vamps up interference with my brain, or my writings, at strategic times, in order to make me look crazy or bad at strategic times.

How do I know that these are weapon attacks? Because of the timing of them and the fact that they often come with verbal threats, etc. But, again; with the field of psychiatry being used to inflict false "mental illness" labels, etc., there is a grave danger for Targeted Individuals – a danger that could have worse results than physical death. This makes it scary to even report these crimes to agencies that are trained to direct us toward a psychiatrist, in order to prove our sanity - prove that the targeting is really happening. Would you be willing to shift toward proving these crimes through honest medical tests for radiation, cell structure damage, brain damage, etc.?

Of course I realize that "life" happens - that accidents, disasters and deaths naturally happen, etc., but there is so much that has happened to me, which is surrounded by chains of strange and unusual things, that it just cannot ALL be cast aside as coincidental. And this list merely hits the tip of the iceberg. Some of it reeks of documented dark/satanic targeting tactics. It appears that someone, had wanted me to be suffering, harmed or dead since the 1970s, and there is no CLEAR and SURE explanation for this. There is, however a few possibilities but I need protection from further targeting, in order to be able to more fully process this and clarify the details of many things.

Why am I being targeted? I'm not sure. I think it may have started as early as the 1950s with technological experimentation on my mother in Canada. I have also wondered if it may have started with my uncle's family being targeted, because he worked for the FBI and I know of three FBI families who appear to be being targeted. It is possible that I have been being targeted by different groups for different reasons, because it has vamped up at times that make it look like it is because of my writings about embracing feelings and healing instead of taking psychiatric pharmaceuticals.

I am citing numerous HIPPA violations, through me, son, grandchildren. 18 USC #241 Conspiracy against right of sovereign, free, God Created, spirit and soul beings, 18 USC #242 – Deprivation of rights under color of law, 18 USC #373 Solicitation to commit a crime of violence, 18 USC #1117 Conspiracy to Murder, 18 USC #2261 Stalking, 18 USC #2340 Torture, 42 USC #1983 Civil action for the deprivation of rights, 42 USC #1985 Conspiracy to interfere with civil rights.

I have been cyber/interstate stalked, electronically raped, human trafficked and all my privacy rights guaranteed through the U.S. constitution have been ignored since 1986 for a lost union election.

Don't send the Brevard County Sheriff here to harass me. You all come with the right equipment to find the frequencies being pumped into us. Or else, write me and tell me where to go to get tested through your offices. On Wednesday, (12-3-2015) I and my wife were headed out to go and do a couple of car repossession jobs in the Nacogdoches, TX area. I have a dba for Wright Way Recovery located in the county of Nacogdoches, Texas.

On this night, we were pulled over and detained for 2 ½ - 3 hours. Upon my release that night, the officer informed me that the firearm had been replaced back in the truck in the center console and that he had informed my wife of her right to have the firearm there and the officer then placed the bullets in my right jacket pocket, placing me in full possession of said firearm, " leading me and my wife to believe that I was constitutionally safe"..

On Saturday ,(12-5-2015) officers with the NCSO, served me with a warrant for "felon in possession of a firearm" and during this stop, the officer did a "search incident to arrest."

After I was in the back of the cruiser and got the gun(the same gun that officers had placed back in the truck on Wednesday night) out of the center console, I was charged with another count of felon in possession of a firearm and forced to make two \$25000 bonds.

I was once asked a question by one of my past probation officers, (who would you rather be in control of your life, the state of Texas or you? (Me. Obviously, I said me.) I want to first say, I blame none other than myself for my past bad decisions. I was sentenced to be subjected to the criminal punishment of the state of Texas for 8 years in which said sentence was discharged in 2003 and may I also add that I've never been convicted of any offense dealing with a gun. My debt to society was paid in full, with no restrictions or so I thought.

In 2004 I was sentenced to 176 days in the Denton County, Texas jail for assault and family violence concerning a previous divorce in 2004. I filed for divorce. Since the divorce, I've moved on in my life and now I have 2 children ages 8 and 5 that I love very dearly and would never leave them or forsake them. Just like any other father (law abiding citizen), I, too, want them to be safe in this world. It was my decision to father them and now it's my responsibility to take care of them and protect them. But at this point I feel that my constitutional right to life, liberty and the pursuit of happiness is being denied through undue process of law.

If my last felony conviction was in 1993, 23 years ago, and my last class, a misdemeanor, was in 2004, 12 years ago, that's the sign of a person that doesn't want problems in his life. We make mistakes in life true, but it's those of us who learn from their mistakes, who deserve the chance to live in peace without being looked at as "savages", "criminals", or being judged by their past as if "no change" is possible. My philosophy is, the only thing in this world that is constant is "change" and without it, you stagnate your own progress in life. I'm not about to hold myself down in life because being a good father is my goal and my job. Breaking the law is not on my list.

I have had several bad calls made on me in the past to the Nacogdoches County Sheriff's Office and because of these calls, the Sheriff's Office has come out to my home and found that either someone has made a crank call, my property has been searched, or numbers on the guns ran and came back clean. I've had my name ran so many times to only find that I'm not on parole or probation and have been free for quite a few years. It is a constant harassment, but if I call or make a complaint because some white guy tells me that I'm marked by the "a.c.", nothing is done because I'm not afraid enough or it's not a serious enough matter and that's not right at all.

In 2007, I was doing repoes for Randy and found out that he was trying to set me up in a bad situation by him asking me to help him do an insurance scam so I, in turn, called the sheriff here in Nacogdoches County and turned him in. As a result, I have been constantly followed and have had to change several cell phone numbers because of it.

I've made complaint after complaint about people following me and have yet to get any help at all, but only to be looked at like I'm a crazy person and ignored. Now some white college kid comes along and files bogus complaints on me that I don't even know. What's funny to me is the fact that he's from Lufkin, Texas, too, but I'm the one that's 'crazy.'

I am neither mentally challenged, insane, nor am I incapable of making rational decisions so why shouldn't I be allowed to have my full constitutional rights back?

I have given the state of Texas everything that I owed for my past transgressions and after this amount of time I refuse to be treated as a common criminal.

I have tried to talk to several persons of authority in this county and Angelina before this ever happened, but to no avail and that's very partial in mine and others' opinion. How do you complain to someone when there's no one who will listen or no one cares? So what do I do? Or what would you do?

I see a lot of stories in the news concerning crooked government, abuse of authority, and judicial cover-ups all the time and it is a shame that there are a lot of citizens out here that are being subjected to this type of unjust and cruel punishment but again, who do you complain to?!!!!

For example, those officers put the gun back in the truck and then when they tried to give me the bullets, I refused to take them so the officer then placed them in my right jacket pocket, but that Saturday morning a warrant was filed. But in order to get that warrant someone had to lie to a judge or they didn't tell that part about the bullets so now I have to concentrate on showing the world that there are either crooked officials behind this, or a honest mistake of law was made. Now when Lostracco sent this case to the grand jury, what information did she use to get the indictment? Was the truth told?

It's funny how my nephew was recently prosecuted by her and during the trial, I was mentioned as having guns in my truck, now all of a sudden some white kid comes up with this gun deal. Why would Sheriff Bridges tell me that he was going to get one of the charges dismissed because they couldn't charge me with it, but never keeps his word? If the first judge would have been told the truth, no warrant would have been issued. But as a result of this, I have been forced to pay a bond on a bogus "felon in possession of firearm" charge.

What's just about this? Nothing. I'm mailing a copy of this letter to whatever necessary people need to see this because it is my opinion that this county has some foul beings in high places.

Good afternoon and thank you for listening to us. Since reporting a corrupt, unprofessional city councilman with a drug record and a pending assault/threatening behavior charge for non-stop

harassment, I have had all of my electronics burned. The city councilman in Birmingham is nicknamed 'Mr. Wireless.' Prior to his being elected, he held one professional job with his parents, and had a wireless company with no website, contact information, no phone number listed, no tax records that I've found, no list of clients, etc. He's a fraud and a ghetto criminal. He is from the worst neighborhood in Birmingham. He has nothing in common with the rest of his district. He refuses to follow the state tenet 'peaceful living' statute.

Since initially reporting him, he is now a leader in the tech community. He and his friends program sensor networks, medical wireless, laser communications, etc. They control and routinely hack into the networks they've established, program malicious code, use network and cell phone jammer systems like CJAM, a train alert jammer used to jam phones used by transportation employees on my phone, hack into the 911 system to evade police detection, etc.

The harassment began when I reported him to a city landlord for unprofessional behavior and harassment. My circuits were turned off in the loft. The rest of the loft circuits were on at the time mine went off. Since the day my circuits were isolated, my communication and electronics have been jammed to the point of being destroyed.

My city loft was illegally entered by him and his girlfriend that had previously lived in the same unit. She and the councilman placed cameras in the building's hallway and underground parking lot and accessed my computer and credit card accounts. They also stole my spare car keys that were on a LARGE Vera Bradley bag purposely so I would not lose them.

After the information was obtained, my internet connection was cut off, and AT&T found my DSL exterior line cut, and my interior line rerouted to his girlfriend's unit at the panel. Three months later, the ethernet port on my Dell Graphics computer burned. Six months later, all the circuits in my car burned.

Since initially reporting him, all my TVs, two cars, three computers, four phones, and ten HVAC units have been destroyed. I have had to move several times because they modulate the powerlines outside my home to the point of destroying heat and air.

Here are some photos of the powerlines and communication lines outside my home.



The holograms occur outside the transformers, amplifiers and repeaters. They form a mesh type network with all the amplifiers, sensors, lines, etc. in the area. They monitor devices they've connected to their network and jam them as they are turned on. They jam 911 calls. They are using a form of public safety phase, frequency and amplitude modulation to destroy electronics, jam communications, jam TV cable reception, jam audio and video, jam small electronics, and generate harmful interference in the form of audio,

infrared, ultrasonic, and radio signals used in medical wireless telemetry, signal commands, and power over ethernet.

Prior to graduating, the school network was destroyed, and numerous computers, printers, and scanners were hacked into and destroyed on a daily basis.

Over the course of the last 15 years, my body has been taken over by FBI handlers for experimentation and surveillance. It started just after September 11, 2001, and it has caused immense challenges for me in my own life. I went from running my own business to slapping myself, yelling and being completely unable to work. I had to sell my business, and I was put into a mental hospital by my step-father. This was done, I believe, as an attempt to discredit me by diagnosing me with bipolar schizoaffective disorder. The repercussions of these programs and science projects have not just been felt by me, others have become targeted individuals and been discredited through false mental diagnoses.

From Water Bottling to Nothing

In 2001, I was running a bottled water company in Southern California and was a successful businessman. At the time, I slowly stop working, and I was going to clubs in Southern California and felt the surveillance that was applied to my body. I could feel the surveillance being collected of other club attendees through my eyes and realized that my body was no longer my own. It was like I had become a science project and was no longer in control of myself. When driving, I would find myself slapping my face and screaming at myself for the things that I had done wrong in life. The torture had kicked in, so I was losing control of my life and body due to the handler controlling me. Since then, I have been unable to regain control of my body.

With the sudden changes in my body, I found myself unable to work. I had to sell my business and move to Texas in 2004 as a result of these changes. After being admitted to a mental hospital in June of 2002, I could feel that the communications with my handler had stepped up and developed a two-way communication aspect.

Within a year later, I could feel the additional foggy and problems caused by implantation in my mind. Around this time period, I was driving through Arizona and my car broke down. I was forced to walk through the desert heat as direct energy weapons were tested on me. I am not sure what this is called by the government, but I dubbed the experience "electricity feet" called by my handler. At the time, I could feel the electricity zapping through my feet as a type of weapon test.

Despite these challenges, I tried to begin another project in California in 2007. Before long, I found myself driving backward on the freeway as what looked like the bouncing stars, drones, or satellites guided me as I looked in to the sky. This experience, as you may guess, was terrifying for me. My body had ceased to be my own for years, but it had now been taken over and was threatening my health, life and ability to work.

The Surveillance and Torture Continues

In June and July of 2010, I was driving from Houston to Dallas for a project before moving on to

California. This ended with a rental automatic driving experience where the car moved itself out of the Phoenix airport. Soon after that, as I was driving thru El Paso, Texas, I experienced something that handlers know and call as the “thunder confirm project”. When this happened, my finger transformed into a machine tapping after that flashed a picture through my mind every time artificial thunder struck. The resulting images were of every place that I had visited or driven through in my life. As I drove, the sky transformed into a dark night as the artificial thunder continued to boom in the surrounding area.

By October 2010, the situation had only worsened. I was walked through a gang-occupied area in California when three Mexican gang members jumped out and began to beat my head. After blacking out, I awoke to find myself in an emergency room. I walked out to lay out in the parking lot, and a satellite began working within my head to repair my skull. This satellite was a part of a test program and science program that led to severe repercussions. As a result, I began losing sight in my left eye and went blind. In 2012, I later had to have cataract surgery performed to recover my eyesight.

Since 2011, I have been the subject of software testing and torture. I have had to live alone to keep others safe from the effects and to prevent them from being targeted individuals as well. At this time, I began to experience two-way communication with my handler. I could both perform voice-to-skull communication and/or communicate using any alphabet keypad that was available to me. This meant that I could communicate any dead keyboard on the same way that you would use a laptop, computer or PDA that does not need to be on and talking back at me when I am in front of it.

Around this time, I was told that they were going to use my body for software testing and other types of tests. My dreams were manipulated on every occasion when I could sleep, and I was the subject of a sleep deprivation attack. Pictures flashed through my mind, and the software caused me to talk to myself as I spent 24 hours each day hooked up to a supercomputer.

Opting Out of the Program

Starting in July of 2015, I started working toward finding a resolution to my life after my mother’s passing. I am not sure what steps need to be taken to remove myself from the targeted individual program, whether I have to write to the Federal Bureau of Investigation or apply with another government office, I would like to be removed as a targeted individual. This targeting has ruined my life and made it impossible to have a relationship, run a business or even communicate effectively.

I did not and do not provide consent to the government or the FBI to use me as a targeted individual. I do not want to be subjected to software testing, human experimentation or torture. Considering my past experiences, I am rightly afraid that I could be controlled for a negative purpose. If the wrong handler takes over, I could be used to harm others, hurt myself or even do something as terrible as a mass shooting without my control. I do not want any of

these things to happen, and I am writing to you today to ensure that they do not. Whoever at the FBI or the government is in control of these programs needs to know that I want out. I do not want to be involved, and I do not trust my handler.

As a final note, I would like to remind you that United States Code 2340 explicitly covers the torture in my case. It says that torture covers an act that causes severe mental pain or suffering and is committed by someone else. Satellite directed energy weapons, an implantation, software and other techniques have been used to control and torture my mind.

I do not trust my handler, and I want out of the program. All of the experiments, tests and surveillance activities that are being performed on me need to be stopped. I am not alone in this; there are thousands of other people who suffer as targeted individuals as well. Many lose their jobs and families, or they are falsely committed to mental institutions. If you could please let me know what I need to do to opt out of this program and investigate who is doing the program, I would greatly appreciate it.

Appendix A

Federal Statutes

FEDERAL STATUTES

The following is a list of federal statutes that the community of targeted individuals feels are being violated by various factions of group stalkers across the United States. This criminal activity is also known as electronic harassment.

10 USC 921 § Article 121 -- Larceny and wrongful appropriation

(a) Any person subject to this chapter who wrongfully takes, obtains, or withholds, by any means, from the possession of the owner or of any other person any money, personal property, or article of value of any kind—

(1) with intent permanently to deprive or defraud another person of the use and benefit of property or to appropriate it to his own use or the use of any person other than the owner, steals that property and is guilty of larceny; or

(2) with intent temporarily to deprive or defraud another person of the use and benefit of property or to appropriate it to his own use or the use of any person other than the owner, is guilty of wrongful appropriation.

18 USC § 35 -- Imparting or conveying false information

(a) Whoever imparts or conveys or causes to be imparted or conveyed false information, knowing the information to be false, concerning an attempt or alleged attempt being made or to be made, to do any act which would be a crime prohibited by this chapter or chapter 97 or [chapter 111 of this title](#) shall be subject to a civil penalty of not more than \$1,000 which shall be recoverable in a civil action brought in the name of the United States.

(b) Whoever willfully and maliciously, or with reckless disregard for the safety of human life, imparts or conveys or causes to be imparted or conveyed false information, knowing the information to be false, concerning an attempt or alleged attempt being made or to be made, to do any act which would be a crime prohibited by this chapter or chapter 97 or [chapter 111 of this title](#)—shall be fined under this title, or imprisoned not more than five years, or both.

18 USC § 241 -- Conspiracy against rights of sovereign, free, God created, spirit and soul beings

If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or

If two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured—

They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.

18 USC § 242 -- Deprivation of rights under color of law

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

18 USC § 245 -- Federally protected activities

(2) Nothing in this subsection shall be construed to limit the authority of Federal officers, or a Federal grand jury, to investigate possible violations of this section.

(b) Whoever, whether or not acting under color of law, by force or threat of force willfully injures, intimidates or interferes with, or attempts to injure, intimidate or interfere with—

(1) any person because he is or has been, or in order to intimidate such person or any other person or any class of persons from—

(A) voting or qualifying to vote, qualifying or campaigning as a candidate for elective office, or qualifying or acting as a poll watcher, or any legally authorized election official, in any primary, special, or general election;

(B) participating in or enjoying any benefit, service, privilege, program, facility, or activity provided or administered by the United States;

(C) applying for or enjoying employment, or any perquisite thereof, by any agency of the United States;

- (D) serving, or attending upon any court in connection with possible service, as a grand or petit juror in any court of the United States;
- (E) participating in or enjoying the benefits of any program or activity receiving Federal financial assistance;

18 US Code § 247 - Damage to religious property; obstruction of persons in the free exercise of religious beliefs

(a) Whoever, in any of the circumstances referred to in subsection (b) of this section—

(1) intentionally defaces, damages, or destroys any religious real property, because of the religious character of that property, or attempts to do so; or

(2) intentionally obstructs, by force or threat of force, any person in the enjoyment of that person's free exercise of religious beliefs, or attempts to do so;

shall be punished as provided in subsection (d).

(b) The circumstances referred to in subsection (a) are that the offense is in or affects interstate or foreign commerce.

(c) Whoever intentionally defaces, damages, or destroys any religious real property because of the race, color, or ethnic characteristics of any individual associated with that religious property, or attempts to do so, shall be punished as provided in subsection (d).

(d) The punishment for a violation of subsection (a) of this section shall be—

(1) if death results from acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, a fine in accordance with this title and imprisonment for any term of years or for life, or both, or may be sentenced to death;

(2) if bodily injury results to any person, including any public safety officer performing duties as a direct or proximate result of conduct prohibited by this section, and the violation is by means of fire or an explosive, a fine under this title or imprisonment for not more than 40 years, or both;

(3) if bodily injury to any person, including any public safety officer performing duties as a direct or proximate result of conduct prohibited by this section, results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, a fine in accordance with this title and imprisonment for not more than 20 years, or both; and

(4) in any other case, a fine in accordance with this title and imprisonment for not more than one year, or both.

18 U.S. Code § 249 - Hate crime acts

(a) In General.—

(1) Offenses involving actual or perceived race, color, religion, or national origin.—Whoever, whether or not acting under color of law, willfully causes bodily injury to any person or, through the use of fire, a firearm, a dangerous weapon, or an explosive or incendiary device, attempts to cause bodily injury to any person, because of the actual or perceived race, color, religion, or national origin of any person—

(A) shall be imprisoned not more than 10 years, fined in accordance with this title, or both; and

(B) shall be imprisoned for any term of years or for life, fined in accordance with this title, or both, if—

(i) death results from the offense; or

(ii) the offense includes kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill.

(2) Offenses involving actual or perceived religion, national origin, gender, sexual orientation, gender identity, or disability.—

(A) In general.—Whoever, whether or not acting under color of law, in any circumstance described in subparagraph (B) or paragraph (3), willfully causes bodily injury to any person or, through the use of fire, a firearm, a dangerous weapon, or an explosive or incendiary device, attempts to cause bodily injury to any person, because of the actual or perceived religion, national origin, gender, sexual orientation, gender identity, or disability of any person—

(i) shall be imprisoned not more than 10 years, fined in accordance with this title, or both; and

(ii) shall be imprisoned for any term of years or for life, fined in accordance with this title, or both, if—

(I) death results from the offense; or

(II) the offense includes kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill.

18 U.S. Code § 373 - Solicitation to commit a crime of violence

(a) Whoever, with intent that another person engage in conduct constituting a felony that has as an element the use, attempted use, or threatened use of physical force against property or against the person of another in violation of the laws of the United States, and under circumstances strongly corroborative of that intent, solicits, commands, induces, or otherwise endeavors to persuade such other person to engage in such conduct, shall be imprisoned not more than one-half the maximum term of imprisonment or (notwithstanding section 3571) fined not more than one-half of the maximum fine prescribed for the punishment of the crime solicited, or both; or if the crime solicited is punishable by life imprisonment or death, shall be imprisoned for not more than twenty years.

18 USC § 1001-- Fraud and false statements: Statement of entries

(a) Except as otherwise provided in this section, whoever, in any matter within the jurisdiction of the executive, legislative, or judicial branch of the Government of the United States, knowingly and willfully—

- (1) falsifies, conceals, or covers up by any trick, scheme, or device a material fact;
- (2) makes any materially false, fictitious, or fraudulent statement or representation; or
- (3) makes or uses any false writing or document knowing the same to contain any materially false, fictitious, or fraudulent statement or entry;

shall be fined under this title, imprisoned not more than 5 years or, if the offense involves international or domestic terrorism (as defined in section 2331), imprisoned not more than 8 years, or both. If the matter relates to an offense under chapter 109A, 109B, 110, or 117, or section 1591, then the term of imprisonment imposed under this section shall be not more than 8 years.

18 USC § 1117 -- Conspiracy to Murder

If two or more persons conspire to violate section [1111](#), [1114](#), [1116](#), or [1119](#) of this title, and one or more of such persons do any overt act to effect the object of the conspiracy, each shall be punished by imprisonment for any term of years or for life.

18 USC § 1111 -- Murder

(a) Murder is the unlawful killing of a human being with malice aforethought. Every murder perpetrated by poison, lying in wait, or any other kind of willful, deliberate, malicious, and

premeditated killing; or committed in the perpetration of, or attempt to perpetrate, any arson, escape, murder, kidnapping, treason, espionage, sabotage, aggravated sexual abuse or sexual abuse, child abuse, burglary, or robbery; or perpetrated as part of a pattern or practice of assault or torture against a child or children; or perpetrated from a premeditated design unlawfully and maliciously to effect the death of any human being other than him who is killed, is murder in the first degree.

Any other murder is murder in the second degree.

(b) Within the special maritime and territorial jurisdiction of the United States,

Whoever is guilty of murder in the first degree shall be punished by death or by imprisonment for life;

Whoever is guilty of murder in the second degree, shall be imprisoned for any term of years or for life.

18 USC § 1512 -- Tampering with a witness, victim, or an informant

(a)

(1) Whoever kills or attempts to kill another person, with intent to—

(A) prevent the attendance or testimony of any person in an official proceeding;

(B) prevent the production of a record, document, or other object, in an official proceeding; or

(C) prevent the communication by any person to a law enforcement officer or judge of the United States of information relating to the commission or possible commission of a Federal offense or a violation of conditions of probation, parole, or release pending judicial proceedings;

shall be punished as provided in paragraph (3).

(2) Whoever uses physical force or the threat of physical force against any person, or attempts to do so, with intent to—

(A) influence, delay, or prevent the testimony of any person in an official proceeding;

(B) cause or induce any person to—

(i) withhold testimony, or withhold a record, document, or other object, from an official proceeding;

(ii) alter, destroy, mutilate, or conceal an object with intent to impair the integrity or availability of the object for use in an official proceeding;

(iii) evade legal process summoning that person to appear as a witness, or to produce a record, document, or other object, in an official proceeding; or

(iv) be absent from an official proceeding to which that person has been summoned by legal process; or

(C) hinder, delay, or prevent the communication to a law enforcement officer or judge of the United States of information relating to the commission or possible commission of a Federal

offense or a violation of conditions of probation, supervised release, parole, or release pending judicial proceedings; shall be punished as provided in paragraph (3).

(3) The punishment for an offense under this subsection is—

(A) in the case of a killing, the punishment provided in sections 1111 and 1112;

(B) in the case of—

(i) an attempt to murder; or

(ii) the use or attempted use of physical force against any person;

imprisonment for not more than 30 years; and

(C) in the case of the threat of use of physical force against any person, imprisonment for not more than 20 years.

(b) Whoever knowingly uses intimidation, threatens, or corruptly persuades another person, or attempts to do so, or engages in misleading conduct toward another person, with intent to—

(1) influence, delay, or prevent the testimony of any person in an official proceeding;

(2) cause or induce any person to—

(A) withhold testimony, or withhold a record, document, or other object, from an official proceeding;

(B) alter, destroy, mutilate, or conceal an object with intent to impair the object's integrity or availability for use in an official proceeding;

(C) evade legal process summoning that person to appear as a witness, or to produce a record, document, or other object, in an official proceeding; or

(D) be absent from an official proceeding to which such person has been summoned by legal process; or

(3) hinder, delay, or prevent the communication to a law enforcement officer or judge of the United States of information relating to the commission or possible commission of a Federal offense or a violation of conditions of probation [\[1\]](#) supervised release,, [\[1\]](#) parole, or release pending judicial proceedings; shall be fined under this title or imprisoned not more than 20 years, or both.

(c) Whoever corruptly—

(1) alters, destroys, mutilates, or conceals a record, document, or other object, or attempts to do so, with the intent to impair the object's integrity or availability for use in an official proceeding; or

(2) otherwise obstructs, influences, or impedes any official proceeding, or attempts to do so, shall be fined under this title or imprisoned not more than 20 years, or both.

(d) Whoever intentionally harasses another person and thereby hinders, delays, prevents, or dissuades any person from—

(1) attending or testifying in an official proceeding;

(2) reporting to a law enforcement officer or judge of the United States the commission or possible commission of a Federal offense or a violation of conditions of probation, supervised release, parole, or release pending judicial proceedings;

- (3) arresting or seeking the arrest of another person in connection with a Federal offense; or
- (4) causing a criminal prosecution, or a parole or probation revocation proceeding, to be sought or instituted, or assisting in such prosecution or proceeding; or attempts to do so, shall be fined under this title or imprisoned not more than 3 years, or both.

18 USC § 1510 -- Obstructing a criminal investigation, conflict of interest roles in government

(a)

Whoever willfully endeavors by means of bribery to obstruct, delay, or prevent the communication of information relating to a violation of any criminal statute of the United States by any person to a criminal investigator shall be fined under this title, or imprisoned not more than five years, or both.

18 USC § 1513 -- Retaliation against a witness/victim

(a)

(1) Whoever kills or attempts to kill another person with intent to retaliate against any person for—

(A) the attendance of a witness or party at an official proceeding, or any testimony given or any record, document, or other object produced by a witness in an official proceeding; or

(B) providing to a law enforcement officer any information relating to the commission or possible commission of a Federal offense or a violation of conditions of probation, supervised release, parole, or release pending judicial proceedings, shall be punished as provided in paragraph (2).

18 USC § 1622 -- Subordination of perjury by procuring another to commit perjury

Whoever procures another to commit any perjury is guilty of subornation of perjury, and shall be fined under this title or imprisoned not more than five years, or both.

18 USC § 2261A – Stalking

Whoever—

(1) travels in interstate or foreign commerce or is present within the special maritime and territorial jurisdiction of the United States, or enters or leaves Indian country, with the intent to kill, injure, harass, intimidate, or place under surveillance with intent to kill, injure, harass, or intimidate another person, and in the course of, or as a result of, such travel or presence engages in conduct that—

(A) places that person in reasonable fear of the death of, or serious bodily injury to—

(i) that person;

(ii) an immediate family member (as defined in section 115) of that person; or

(iii) a spouse or intimate partner of that person; or

(B) causes, attempts to cause, or would be reasonably expected to cause substantial emotional distress to a person described in clause (i), (ii), or (iii) of subparagraph (A); or

(2) with the intent to kill, injure, harass, intimidate, or place under surveillance with intent to kill, injure, harass, or intimidate another person, uses the mail, any interactive computer service or electronic communication service or electronic communication system of interstate commerce, or any other facility of interstate or foreign commerce to engage in a course of conduct that—

(A) places that person in reasonable fear of the death of or serious bodily injury to a person described in clause (i), (ii), or (iii) of paragraph (1)(A); or

(B) causes, attempts to cause, or would be reasonably expected to cause substantial emotional distress to a person described in clause (i), (ii), or (iii) of paragraph (1)(A),

shall be punished as provided in [section 2261\(b\) of this title](#).

18 USC § 2331 – Domestic Terrorism

the term 'domestic terrorism' means activities that--

(A) involve acts dangerous to human life that are a violation of the criminal laws of the United States or of any State;

(B) appear to be intended--

(i) to intimidate or coerce a civilian population;

(ii) to influence the policy of a government by intimidation or coercion; or

(iii) to affect the conduct of a government by mass destruction, assassination, or kidnapping;
and

(C) occur primarily within the territorial jurisdiction of the United States.'

18 U.S. Code § 2340 – Torture

As used in this chapter—

- (1) “torture” means an act committed by a person acting under the color of law specifically intended to inflict severe physical or mental pain or suffering (other than pain or suffering incidental to lawful sanctions) upon another person within his custody or physical control;
- (2) “severe mental pain or suffering” means the prolonged mental harm caused by or resulting from—
 - (A) the intentional infliction or threatened infliction of severe physical pain or suffering;
 - (B) the administration or application, or threatened administration or application, of mind-altering substances or other procedures calculated to disrupt profoundly the senses or the personality;
 - (C) the threat of imminent death; or
 - (D) the threat that another person will imminently be subjected to death, severe physical pain or suffering, or the administration or application of mind-altering substances or other procedures calculated to disrupt profoundly the senses or personality;

31 USC § 5328 -- Whistleblower protections

(a) Prohibition Against Discrimination.—

No financial institution or nonfinancial trade or business may discharge or otherwise discriminate against any employee with respect to compensation, terms, conditions, or privileges of employment because the employee (or any person acting pursuant to the request of the employee) provided information to the Secretary of the Treasury, the Attorney General, or any Federal supervisory agency regarding a possible violation of any provision of this subchapter or section [1956](#), [1957](#), or [1960](#) of title [18](#), or any regulation under any such provision, by the financial institution or nonfinancial trade or business or any director, officer, or employee of the financial institution or nonfinancial trade or business.

(b) Enforcement.—

Any employee or former employee who believes that such employee has been discharged or discriminated against in violation of subsection (a) may file a civil action in the appropriate United States district court before the end of the 2-year period beginning on the date of such discharge or discrimination.

42 USC § 1983 -- Civil action for deprivation of rights

Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory or the District of Columbia, subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress, except that in any action brought against a judicial officer for an act or omission taken in such officer's judicial capacity, injunctive relief shall not be granted unless a declaratory decree was violated or declaratory relief was unavailable. For the purposes of this section, any Act of Congress applicable exclusively to the District of Columbia shall be considered to be a statute of the District of Columbia.

42 USC § 1985 -- Conspiracy to interfere with civil rights

(3) Depriving persons of rights or privileges

If two or more persons in any State or Territory conspire or go in disguise on the highway or on the premises of another, for the purpose of depriving, either directly or indirectly, any person or class of persons of the equal protection of the laws, or of equal privileges and immunities under the laws; or for the purpose of preventing or hindering the constituted authorities of any State or Territory from giving or securing to all persons within such State or Territory the equal protection of the laws; or if two or more persons conspire to prevent by force, intimidation, or threat, any citizen who is lawfully entitled to vote, from giving his support or advocacy in a legal manner, toward or in favor of the election of any lawfully qualified person as an elector for President or Vice President, or as a Member of Congress of the United States; or to injure any citizen in person or property on account of such support or advocacy; in any case of conspiracy set forth in this section, if one or more persons engaged therein do, or cause to be done, any act in furtherance of the object of such conspiracy, whereby another is injured in his person or property, or deprived of having and exercising any right or privilege of a citizen of the United States, the party so injured or deprived may have an action for the recovery of damages occasioned by such injury or deprivation, against any one or more of the conspirators.

WHEREAS, the Space Preservation Act and the companion Space Preservation Treaty has established a permanent ban on all space-based weapons, on the use of weapons to destroy or damage objects or persons from or that are in orbit; and the permanent termination of research and development, testing, manufacturing, production and deployment of all space-based weapons; and

This technology is also being used as a remote, invisible torture instrument by transmitting inexplicable sounds, voices, images, smells and tastes directly into the brain, creating numerous pains and sensations throughout the body and significantly impacting sleep patterns, brain functioning, energy level and emotional states. The technology may have a “kill switch”, capable of causing instantaneous heart failure or a stroke. I do not know if a facility exists which blocks this type of satellite transmission. Everyone is potentially at risk, including our government and military leaders.

Aaron Alexis, the Washington Navy Yard shooter, Miriam Carey, shot fleeing a White House checkpoint in October 2013, Dominic Adesanya, one of the White House fence jumpers, and Myron May, the shooter at Florida State University last November, were all targeted and tortured prior to those events. Eddie Ray Routh may have been targeted, tortured and provoked to kill Chris Kyle, the highly decorated Navy SEAL portrayed in the film *American Sniper*, and his friend Chad Littlefield. Many other seemingly inexplicable tragedies, including mass shootings going back decades, and an untold number of suicides have been caused by people being tortured past their breaking points. This is the largest crime in U.S. history.

There are millions of satellite torture victims all over the world. Most do not even know this technology exists. Many are incorrectly, or even maliciously, pushed into the mental health system. Over the past decade or so, information has sprung up everywhere – books, articles, websites, blogs, petitions, victim testimonials, support groups, etc. Published by torture victims trying to make sense of something almost impossible to comprehend, the information is understandably all over the board.

Search “targeted individuals”, “organized stalking”, “gang stalking”, “electronic harassment” and “technological assault”. One prominent support group, *Freedom from Covert Harassment and Surveillance* (www.freedomfchs.com), was formed 10 years ago and has members and affiliated support groups across the country and throughout the world.

Since the satellite technology is classified, and no information has been released to the public, there are many different theories regarding the technological assault. Any viable theory has to explain how people remain connected on airplanes at 35,000 feet over the middle of the ocean or while traveling in other countries. Satellite is the only technology that can do that.

Many victims of satellite surveillance and torture also experience “organized stalking”. This is stalking, monitoring, harassment and intimidation conducted by a large, organized, well-funded group. Organized stalking is a form of psychological torture which uses tactics similar to those used by corrupt regimes throughout history to manipulate and control their populations. The Germans had a name for the psychological terror inflicted by the Stasi, the secret police, in former communist East Germany – zersetzung or decomposition. American citizens in communities across the United States are being victimized by organized stalking. The size and reach of the organized stalking apparatus suggest possible government involvement and funding.

I have been a Colorado resident since 1999 and a victim of organized stalking and satellite surveillance and torture for roughly the past decade. I attached a copy of a paper I wrote in May 2014, “End the Torment”. It describes some of my personal experiences. I have reported these crimes to the Denver Police Department, the Douglas County Sheriff’s Office and the Summit County Sheriff’s Office. I have also contacted the FBI on numerous occasions. I attached a copy of a letter to FBI Director James B. Comey dated April 30, 2015. There has not been any follow up from the FBI to these numerous requests for assistance, and to my knowledge, no investigation has ever been conducted. The brutal torture continues every second of every day.

Victims across the country have filed reports with local and federal law enforcement. The crimes are not being investigated. It is being summarily dismissed as mental illness. Torture victims are not only being ignored, they are often subjected to defamatory labels. It is not mental illness, yet the mental health profession continues to provide cover for these crimes, and “contain” victims, by handing out false diagnoses and prescribing potentially dangerous, mind-altering drugs.

Organized stalking and satellite surveillance and torture impact most mental health diagnoses and explain so much the mental health profession has never been able to explain, even after many decades and enormous expenditure of time, money and human resources. The DSM and mental health practices will be completely revamped when this situation is finally exposed. The mental health profession has massive civil and criminal exposure, and has a duty to tens of millions of patients to investigate this issue.

Many horrific crimes have been committed: unimaginable privacy violations, stalking, assault, torture, mass murder, domestic terrorism, crimes against humanity, and possibly genocide. Ruthless, sadistic criminals have done catastrophic damage, over decades, which could literally bankrupt the U.S. morally and financially. A massive education and relief effort, and victim compensation fund, will be required when this issue is finally exposed.

This is a national emergency. Millions of Americans are under silent, invisible attack. This technology could potentially allow a hostile government or group to take control of the United States by killing, or threatening to kill, anyone who resists. Hitler could not have been stopped. These deadly satellites, being used to assault, torture and kill people throughout the world, must be identified and locked down or destroyed immediately. Mr. President, there is not a more critical issue on your agenda.


